RELIABILITY - FAILURE RATES

The current status of reliability analysis is reported in summary form in Table 1.1. This table contains tabulations of the failure rates associated with each major configuration of G&N systems. These have been derived from the parts count of each assembly using generic-type failure rates, modified only by the stress applied to each part and its singular application in the system. From these data, estimations of mission success probabilities may be calculated.

2. Hardware Tests

a. Continued testing the Auxiliary Memory Unit. The erasable program is now operating using DANCE 306 and AMDANCE Rev. 10.

b. Ran a Transient Response test of current and voltage variations in the Standby bus return lines for MSC. Transient current flow (150-200 ma peak) can occur in LM structure due to voltage step changes occurring when heater power is switched on or off.

SYSTEM ENGINEERING

- A. Program Testing
- 1. SUNDANCE

a. Supported testing of the SUNDANCE 306 program with the flight type radar.

b. Testing was performed on radar and optics routines in line with the additional LUMINARY test requested by NASA.

2. COLOSSUS

a. The Colossus II Level 3 testing has been completed. Level 5 testing is complete except for the optics operational programs. Level 3 documentation has been completed and Level 5 documentation is 50% complete.

b. COLOSSUS IIA testing has not begun. A limited effort is planned.

c. A special program for computing shaft and trunnion during tests of the prelaunch alignment verification was completed. (STG Memo. No. 1314.)

3. LUMINARY

a. The LUMINARY I Level 5 testing has been completed. Documentation was completed except for tests of P52and P57 (AAP3. AAP4 and AAP7). The report on P57 (AAP7) will not be issued since this program is not in the mission for which LUMINARY I is planned and significant changes were made in LUMINARY IA.

b. LUMINARY IA Level 3 testing has been completed except for 7 of 16 radar (RP) tests. Documentation on all but 5 of the completed tests is complete.

4. SFRR

The Mission D SFRR was supported and preparation for support of Mission D was initiated.

B. S/C Test Programs

1. Changes have been made to the GAP assembler and the new K-START generation program. These changes will allow all necessary information for the generation of K-START tapes to be stored on one magnetic tape instead of approximately 15 tapes previously required.

2. Segments were generated for the COMANCHE IMU Performance Test and the IRIG SF Test. K-START tapes were generated and verified.

3. Segments were generated for the LUMINARY IA IMU Performance Test and the IRIG SF Test. K-START tapes were generated and verified.

4. STG Memo. No. 1297 was distributed describing XSM changes required for LUMAGS at other azimuths.

5. STG Memo. No. 1293 was distributed indicating a simplified method for performance of the AOT functional accuracy test.

6. Continued work on the PIPA bubble test.

7. A special landing Radar downlink program was checked out and debugged.

C. Flight Support

1. The Apollo 9 flight was supported with personnel at KSC, MSC and 24 hours a day at the MIT SCAMA room.

2. An analysis of the PIPA anomolies in Apollo 9 was performed and a report is being prepared. (STG Memo. No. 13?6)

3. The planned use of P57 in the G Mission was analyzed particularly with regard to gyro drift measurements. Further work is required and a report is being prepared.

D. Miscellaneous

1. Supported testing of the effects of gyro failure modes with the flight type radar.

2. A program, STARTRAK, for use of a star tracker in the P52 alignment program was generated and is being debugged in the lab.

3. The work on CROSSLINK was supported and the implementation. impact on displays, and time sharing were investigated.

SIMULATION AND CHECKOUT

A. K-START Tape Verification on the Digital Simulation.

1. A one-for-one comparison of the plots and edited listings obtained from a digital simulation of the SUNDANCE 302, 292 and 306 LM RCS/TVC DAP Polarity Test have been compared with actual test results obtained at KCS on LM-3. These comparisons support the decision not to rerun a polarity test on LM-3 following installation of flight ropes.

2. The plots and edited listings from a digital simulation of the LUMINARY 69 RCS/TVC DAP Polarity Test have been provided to KSC.

3. The plots and edited listings obtained from digital simulations of the COLOSSUS 237 and COLOSSUS IA RCS/TVC DAP Polarity Tests have been provided to KSC for comparison with actual test results. A comparison of the COLOSSUS 237 simulation results with the COLOSSUS IA simulation results indicated that, in terms of the polarities, they are identical.

 The simulation of SUNDANCE 306 K-START tapes provided by AC Electronics has been completed.

5. The capability to perform digital simulations of both CM and LM RCS/TVC DAP Polarity Tests is now fully operational. Edited listed and plotted results permit rapid test evaluation. These data are used to support test evaluation and the definition retest requirements at KSC. In addition, these simulation results are now being used to support test design, thus relieving required lab verification time.

6. The digital simulation of LUMINARY 69 K-START tapes provided by AC Electronics has been completed. (STG Memo. No. 1317.)

7. The digital simulation of COLOSSUS IA K-START tapes provided by AC Electronics has been completed. (STG Memo. No. 1324.)

8. COLOSSUS II K-START tapes provided by AC Electronics are currently being simulated.

9. RCS/TVC DAP Polarity Test K-START tapes provided to KSC to support LM and CM polarity tests have been simulated. The listed and plotted results are available.

10. The capability to simulate the G&N/LV Polarity Test K-START tape is being developed.

B. Test Design

× ...

1. Effective for CM-106 VAB testing (and all subsequent submittals of CM RCS/TVC DAP Polarity Test K-START tapes) a number of changes have been made in the RCS/TVC DAP Polarity Test. The Pitch and Yaw RCS tests were changed to incorporate the 7.25 degree offset angle between the vehicle body axes and the RCS DAP control axes. The DAP maneuver rate of the YAW RCS test was changed from 0.5 deg/sec to 0.4 deg/sec and the CDU incrementing portions of the Auto-Maneuvers were eliminated.

2. A new K-START tape has been provided for CM-106 VAB tests. This is for the VHF Ranging Test (F09C106-K00091-00). Subsequent revisions or new releases of this K-START Tape will be the responsibility of AC Electronics.

The AOT Functional Accuracy Test has been simplified to require only one 3. target positioned in the portion of the field-of-view which overlaps for two detent positions. Running this test in the SLA with LUMINARY 69 ropes obviates the need for a special K-START tape loaded program to calculate angles.

A number of changes have been made to the TSCD to reflect actual test 4. specifications for the CM RCS/TVC DAP Polarity Tests. These changes are consistent with actual test results and simulation results.

Two K-START tapes are being prepared to surport Launch Vehicle Space-5. craft Guidance Interface Testing. One of these tests is the polarity of IMU error signals to the engine actuators and the other is for an abbreviated simulated mission to test the takeover capability.

The G&N/LV Polarity Test and Simflight have been designed. The K-START 6. tapes needed to perform these tests at KSC on CM-106 have been provided.

A LR Data Accuracy Read Routine has been designed to enable strobing of 7. the Landing Radar at the flight strobe rate. A K-START tape needed to perform this function at KSC will be provided to support LM-5 tests in the VAB.

Several changes are now being considered for the IMU Performance Test 8. These would provide automatic calls to the specific downlist, and would add a routine to curve fit CDU data to provide an independent measure of gyro-drift. A decision on these proposed changes will be made early in April.

A new K-START tape is being designed to provide a Radar Simflight capability 9. in the MSOB for LM-6 and subsequent vehicles. Previously this testing was supported with F10L004-K00078-01, the simulated mission tape.

2. One K-START Tape, the IMU Performance Test, is now being generated directly from segments. This has necessitated a slight change in the format of the K-START tape listing. Copies of the new listing format are being pro-

vided to all users. Other K-START tapes are also being converted to this new manufacturing concept.

TEST EQUIPMENT

A. Uplink-Downlink Timer

 A change was made in the uplink-downlink timer to initiate downlink recording upon a reset command.

 Increased downlink recording intervals have been provided. The laboratory is now capable of recording downlink for intervals up to five minutes at a preselected time.

B. Uplink Transmitter

The logic has been completely built and is approximately 40% checked out on the bench. The interface cables must still be fabricated. It is expected that the unit will be operational in the laboratory by late April.

C. Trace

1. The logic design has been completed. the wire wrap data has been generated, and the logic trays are at Gardner Denver for wire wrap. The wire trays are due back in mid-April.

2. All of the NAFI PC boards have been received and the finished NAFI assemblies should be completed in mid-April.

3. The Coroner front panels have been assembled and wiring is nearly complete.

4. Data has been generated to verify the 360 computer printout programs and

is in the process of being coded.

5. Project documentation is proceeding satisfactorily.

6. In all, the major program delays and difficulties would appear to be in the past.

All of the equipment has been repaired. The frequency of failues indicates a need for review of our maintainence procedures and some special attention to having adequate spare parts on hand (especially long lead items). This area will receive special attention in the coming months.

E. DAC Monitor

The DAC Monitor was revised to provide a readout in degrees rather than volts.

F. Resolver Error Analysis

A study of rate induced quadrature error in resolvers was completed. The effect was shown to be negligible for present design.

MISCELLANEOUS

1. Submitted results of MIT review of KSC process specifications. (ND 1002379 and ND 1002380).

2. Supported LM and CM checkout coordination meetings.

3. A study of methods to optimize non-linear systems by the adjustment of a control function is underway. Techniques under study include transition matrix and steepest descent methods. True aim of these investigations is to provide

enough information to write a computer program to determine a control function that provides an optimum solution to two point boundary value problems.

4. The launch of Apollo 9 was supported at KSC, MSC and MIT.

5. Presentation of system test activities and results was made to NASA at the Quarterly Status Review.

6. System integration problems and requirements for various improved subsystem designs were reviewed.

7. Two programs utilizing steepest descent and transition matrix techniques for the solution of two point boundary problems have been written. They are now being debugged and documented.

8. Prepared Engineering change proposals for Lunar Exploration Program hardware modifications.

SECTION 4

G&N COMPUTER STATUS

DESIGN ANALYSIS & SUPPORT

A. Analysis Facility Activities

The equipment continued to be used in support of the auxiliary memory tests in pursuant of the requirements of T.O. #36 and for testing of the Portafam Assembly of T.O. #37. The progress under both T.O. #36 and T.O. #37 is reported separately.

B. Design Support

1. The testing of rope modules in a computer while being subjected to thermal environment and vacuum environment has been introduced in order to detect failures of the nature that were detected during S/C testing, that is the failure due to slow diode switching and the workmanship failure in vacuum tests of LM4. To detect these failure modes requires continuous monitoring of the rope module as it is being subjected to changes in environmental conditions. The previous test procedure, using the module test station, checks the operation at the extremes of temperature but not during transition and had no requirement for vacuum testing. These new tests are being documented and will be released as a new Purchase Specification. In the interim all ropes are being tested to the requirements of the new documentation.

2. The EL light failure mechanism is the result of marginal glass strength when subjected to spacecraft environment of vacuum and high temperature. A design change to bond safety glass to the surface has been made and the qualification tests are completed. A separation of the safety glass and EL glass surface that occurred during the qualification tests was analyzed and corrective action taken in the process of bonding the glass. The separation is not considered serious since if it occurred in flight the panel is still functional.

3. A minor effort was expended working with a tiger team to investigate the flight failures in the Entry Monitoring System of the spacecraft. One of the meetings of the tiger team was attended, the second one could not be attended because of weather conditions.

4. The proposal to use modules from computers of the 2003200 configuration in computers of the 2003993 configuration was evaluated. Initially document changes in the 2003993 configuration was proposed to make the usage an either or type of configuration for the modules used. This was rejected at MIT because there is a reliability risk even though it may be difficult or impossible to identify the magnitude of the risk. The procedure that was finally adopted was to write a waiver identifying the use of the older module and stating the differences thus flagging and permitting the evaluation of each case individually when the use of the computer is known.

5. Several proposals for expanding the storage capability of the computer were studied. Two of these were carried to sufficient detail to make it possible for a preliminary cost proposal to be submitted. One proposal was to design an external black box using Apollo type modules which would have a capacity of 2K additional words of erasable storage. The second proposal was to redesign Tray B and increase the capacity of the erasable memory designed for the Portafam system.

C. Documentation

1. A new Purchase Specification for the sale of ropes was submitted to DRB and is being reviewed. This will include the new tests with the modules operating in a computer.

2. The documentation for the new EL light design and the various Purchase

Specification changes were reviewed at DRB and passed.

4

D. Component Problems

Two computer failures (C-27 and C-34) have been analyzed. One failure (C-34) was the result of contamination in the flatpacks. This was verified by reproducing intermittant failures on the suspected module output during module vibration. The gate that was most likely the one with the contamination was opened accidently before reliability analysis was performed thus destroying any evidence to confirm the failure. The other failure (C-27) was the result of bond failures of the type called gold rich. This type of failure mode is extremely serious and it is the first to be detected after computer sale. The history of this type failure mode is being reviewed again to see if there is anything significant about this particular failure. Some of the reports that deal with this subject are a Raytheon RAL Test File Report #2985 and MIT letter AG403-67. So far there are no new conclusions or recommendations that can be drawn.

APOLLO GUIDANCE COMPUTER PROGRAMMING SUMMARY

MISSION "C PRIME" - COLOSSUS I (Rev 237) MANNED CSM WITH LUNAR CAPABILITY

In an historic first, this country sent men to the moon in Apollo 8 with MIT's Guidance, Navigation and Control System sharing in a remarkable performance of Apollo spacecraft, flight crew, and ground operations.

The liftoff of Saturn launch vehicle 503 occurred 7:50 am EST on 21 December 1968, and injected astronauts Borman, Lovell, and Anders in Spacecraft 103 towards the moon which they orbited ten times on Christmas Eve before returning to recovery in the Pacific on the morning of 27 December after a 147 hour flight.

Few problems and superb performance were experienced with the GN&C. Both the inertial subsystem and the computer were left operating the whole mission. The crew, using the optics, made periodic IMU alignment checks and many navigation measurements. For long periods of time the navigation state vector was kept up to date only by the on-board measurements. In a different location in the computer an MSFN ground tracking determined state vector was held and renewed periodically by up-telemetry. Although these two had no significant difference, mission control overwrote the on-board navigation data with the MSFN values before each maneuver so that they would be accomplished on the basis of the ground tracking initial conditions. All major maneuvers and

entry were guided and controlled automatically by our system and monitored by the crew.

The inertial measurement unit was given two major realignments by crew star sightings to set up new preferred orientations, first for lunar operations and then for earth return. Many star sighting alignment corrections were performed, typically several hours apart and requiring correction angles of the order of only a few hundredths of a degree. These realignments gave the data required to check IMU drift for each of the three gyros. The drift was uniformly consistent and matched the low values measured on the ground before launch. Likewise, accelerometer output during free fall gave a most satisfying measure of accelerometer bias stability. Dr. Draper's prognosis of superior inertial component performance in space has surely been demonstrated.

The mission plan for translunar navigation was to (1) confirm the on-board navigation capability, (2) confirm independently that the lunar arrival would be safe, and (3) to calibrate Captain Lovell's use of the earth horizon as a navigation

target. Loss of communication would require on-board sightings alone to be used on the return to assure safe atmospheric entry.

The crew was aided in optics star acquisition by the automatic pointing feature of the IMU realignment program (P52). Likewise, automatic acquisition pointing of both landmark and star lines in the midcourse navigation program (P23) allowed Lovell to make quickly each of over 200 cislunar earth and lunar horizon sextant navigation sightings. MIT had preselected the best visible stars of the 37 in the computer's star catalog for navigation use. His superposition of the star in the sextant on the earth's illuminated limb was at a remarkably uniform altitude above sea level but about 8 kilometers lower than he selected as his subjective target a few weeks before the flight on the MIT simulator. This horizon bias was determined independently during the first part of the outbound leg by both MSC and MIT. His performance with the optics was excellent even when fatigue was otherwise evident. The consistency of all his "marks", except when the spacecraft was close to the target body, was rarely greater than the 10 arc second quantization size of the sextant trunnion angle readout.

The sextant data were processed in the flight computer with Dr. Battin's recursive estimation formulation and as they approached the moon this on-board navigation was for all intents the same as the MSFN ground tracking data. There was no reason, then, why they couldn't have used this on-board state vector to initialize the lunar orbit insertion maneuver. This would have been an impressive demonstration of the actual complete on-board capability. However, the flight plan specified a state vector update before lunar orbit insertion, and the Flight Controller chose to proceed with this plan, since there was no overriding argument for deviation.

The Saturn guided translunar injection errors and the subsequent manual maneuvers needed to separate from a persistent SIVB they couldn't seem to shake, required a 25 ft/sec correction using the main SPS engine. This was made at 11 hours into the mission. The next two scheduled midcourse corrections were not necessary and were not made. The final translunar midcourse correction, made at 8 hours before lunar orbit insertion was only 3 ft/sec using the small reaction control jets.

The anxious wait for the spacecraft to make its first reappearance from in back of the moon on Christmas Eve following the out-of-sight lunar orbit insertion maneuver was rewarded with the report from the crew that the on-board computer gave their orbit as 60.5 by 169,1 nautical miles altitude...so close to the planned 60 by 17^o orbit that the unavoidable emotional tension was broken with

unrestrained cheers. About 25 minutes later the ground reported that radar tracking had established an orbit comparing favorably with the on-board data. Two orbits later, after the circularization maneuver, the spacecraft emerged in sight with the satisfying report of a 60.6 by 60.7 nautical mile lunar orbit.

During lunar orbit, Lovell used the sextant and scanning telescope to track known lunar reference points, including potential landing sites. These data were telemetered to earth for post flight analysis.

The critical 3500ft/sec return-to-earth maneuver early Christmas morning was guided so accurately that only a single 5 ft/sec correction, made five hours later, was required to hit the center of the atmospheric entry corridor 42 hours later.

Our MIT teams of experts at Florida, Houston and Cambridge who provided support to mission control, were constantly monitoring and checking the progress of the flight and were called upon several times for consultation and recommendations.

A false alarm hardware problem which acquired the nickname "travelling trunnion" was manifest by a transient change of the optics trunnion indication in the computer and was associated with the procedure of starting optical sightings. In each case it occurred, Lovell merely rezeroed and proceeded without hesitation or concern. With the limited data we had available it took some ingeneous sleuthing by our team to be able to certify confidently continued safe use of the

optics. The curious action of the trunnion indication was finally understood completely only after discussing with Lovell the details of the procedures he used. The phenomenon involves the way in which the optics behave with power off in the free-fall environment of space flight. There was no failure or degradation of any GN&C hardware in the mission.

Considering the huge workload of GN&C use, which sucessfully exercised all functions except rendezvous, it is surprising so few operational problems were experienced in this flight. In the several cases which did occur, the computer gave proper alarm indication and the astronauts were able to recover without help from the ground. In three cases of question, MIT examined the contents of the erasable memory and was able to verify that corrections did not need to be telemetered up.

On the way back from the moon the on-board and the ground tracking navigation were essentially identical. Both were well within the tolerance needed for entry control. Lovell was still using the same altitude horizon for his P23 navigation he used on the way out. Our system controlled automatically the 36, 20^o

ft/sec atmospheric entry to a spectacular landing next to the recovery carrier The ship has reported splashdown coordinates within a third of a mile of the target coordinates in the flight computer. 1

MISSION "D" - COLOSSUS IA REV 249 and SUNDANCE REV 306

During the reporting period level 6 "Mission Performance Testing" was completed by MIT/IL in preparation for Mission "D" APM#9. The level 6 testing of Colossus IA consisted of approximately 6^o mission oriented tests and approximately 55 on Sundance. The results of these tests were summarized and reported at The Apollo Flight Software Readiness Review (FSRR) held on January 27-28, 1969 at MSC. At this meeting, it was determined that the command module program (Colossus IA), and the LM program (Sundance) were capable of performing the Apollo 9 mission in a satisfactory manner.

During the actual flight MIT/IL flight support was given from the Cambridge Facility and residents at KSC and MSC. Subsequent to the flight, post flight analysis of the flight data received from MSC has been performed at MIT/IL.

COLOSSUS 2 - MANNED CSM (LUNAR CAPABILITY)

During the reporting period level 3 and level 4 testing was completed on the Colossus 2 program. The Colossus 2 program was released to rope manufacturing on 2/11/69 with the nomenclature Comanche Rev 44. On 3/3/69 Comanche was re-released at Rev. 45 which include a modification to the B3 module. Since that time the level 3 and 4 tests have been re-run on the latest version of Comanche Rev 45 and a test plan for Mission "F" type testing has been developed.

The Software Flight Readiness Review for Mission "F" is scheduled for 30 April 1969.

COLOSSUS 2A - MANNED CSM (LUNAR CAPABILITY)

During the period of 3 March 1969 to 15 March 1969 eight (8) Program Change Requests (PCR's) and eight (8) Comanche Rev 45 anomolies were incorporated into and fixed in the Comanche assembly. A Colossus 2A program which was retested by running the level 3 and 4 tests was released to rope manufacturing on 15 March 1969 as Comanche Rev. 51. Level 5 testing of Comanche Rev. 50 and 51 have been completed.

LUMINARY 1 - Rev 69 MANNED LM (LUNAR CAPABILITY)

During the reporting period a level 6 test plan has been developed and testing started in support of Mission "F". The planned completion of this effort is sched-

uled for mid-April 1969. The Software Flight Readiness Review for Mission "F" is scheduled for 30 April 1969 at MSC.

LUMINARY 1A - MANNED LM (LUNAR CAPABILITY)

2

During the reporting period another version of the Luminary 1 program was coded and level 2, 3 and 4 tested. This new version corrected approximately twenty (20) anomolies found in Luminary 1 and incorporated approximately fortyfive (45) Program Change Requests. A PRE-FACI review by MIT/IL and MSC personnel was held at MIT/IL on March 24 and 25 to review the changes made in Luminary 1A. The schedule for release to rope manufacturing is set for the first of April 1969 Level 5 testing will be conducted on the Luminary 1A assembly after that date.
