

Purpose:

The purpose of this report is to describe a method of orbit rate torquing compensation for use in Module 10 to correct for errors introduced while in eccentric orbits.

Summary:

The method described will correct the pitch attitude error angle, the pitch gimbals used in the rendezvous computation and the measured accelerometer outputs and transform them into a corrected local vertical coordinate frame, displaced by an angle $\Delta\theta$ from the true platform frame. The time which the platform mode switch is turned to ORB RATE is entered via the MDIV before switching the computer mode switch to RNDZ or CATCHUP. The ground is expected to send via DCS the following parameters prior to entering the RNDZ mode.

e = eccentricity

w = platform torquing rate

η = mean orbital rate

Discussion :



The following equations are to be inserted in the Rendezvous and Catches computations of Module 3 to arrive at a configuration to be known as Module 10, for the purpose of correcting the orb. rate torque of the platform.

$$e = \text{orbit eccentricity}$$

$$\omega = \text{platform torque rate} \quad \left\{ \begin{array}{l} \text{MDIU/DCS loadable} \\ \text{on same scale as } T_{01} \text{ & } T_{02} \end{array} \right.$$

$$\eta = \text{mean orbital rate}$$

$$tSET = \frac{\text{present space craft elapsed time}}{\text{MDIU insert and display}} - \text{MDIU insert and display}$$

$$T_{01} = \text{time last at perigee} - \text{MDIU/DCS loadable}$$

$$T_{02} = \text{time platform last switched to ORB RATE mode} - \text{MDIU insert and display}$$

$$M_1 = \overset{\text{present}}{\eta} \text{mean anomaly at time } t_{\text{SET}} = \eta (t_{\text{SET}} - T_0)$$

$$M_2 = \text{mean anomaly at time } T_0 = \eta (T_0 - T_0)$$

$$\theta_1 = \overset{\text{present}}{\eta} \text{true anomaly at time } t_{\text{SET}}$$

$$\theta_2 = \text{true anomaly at time } T_0$$

The true anomaly will be determined by the truncated series involving mean anomaly and eccentricity:

$$\theta_N = (M_N + 2e \sin M_N) \Big|_{N=1,2}$$

$$\theta_{12} = (\theta_1 - \theta_2) = \text{difference in true anomaly travelled during last ORB RATE forcing period to present time.}$$

$$\Delta \theta_b' = w(t_{\text{SET}} - T_0) - \theta_{12} = \text{correction angle applied to computation.}$$

$$\theta_b = \theta_b - \Delta \theta_b' = \text{corrected pitch gimbal angle}$$

$$\Delta \theta_{sc} = \Delta \theta_{sc} - \Delta \theta_b' = \text{corrected pitch attitude error angle}$$

$$\left. \begin{aligned} F_x &= F_x \cos \Delta \theta_b' - F_y \sin \Delta \theta_b' \\ F_y &= F_y \sin \Delta \theta_b' + F_x \cos \Delta \theta_b' \\ F_z &= F_z \end{aligned} \right\} \begin{array}{l} \text{corrections to} \\ \text{sensed velocity} \\ \text{changes.} \end{array}$$
