Outside on the Town Commons, the street fair will showcase The ArtsCenter's wide range of programs, featuring caricature drawchildren, improv acts, musical performances and more.



CARRBORO — After a long negotiation over design, pricing and what would happen to current residents, the Carrboro Board of Aldermen on Tuesday approved a rezoning to allow the Pine Grove Mobile Home Park on Old Fayetteville Road to be redeveloped as a cluster of 39 energy-efficient homes.

The board, which last year had sparred with those managing the project over affordable-housing requirements, unanimously approved rezoning 4.66 acres for a mix of small homes ranging from 1,100 square feet to 1,350 square feet. The water- and energy-efficient homes would also share in a large photovoltaic array, which would sell power back into the grid to help generate revenue for Veridia's homeowner association.

Trip Overholt, a partner in the project, said its just one of a number of ways the project would help make it more affordable for residents.

As part of its agreement with the town, home prices for Veridia would be less than \$300,000.

The land could have been redeveloped without seeking approval from the town. In 1970, the previous owners of the mobile home park successfully sued the town and received a special zone allowing for a high-density development. Ultimately, Overholt and his partners opted to seek a rezoning so that individual lots could be created. Overholt said that in the current lending market, it's easier to get a loan for a home built on a fee-simple lot than if the project would offer condominiums and the land was held jointly. Overholt praised the town for sticking to its positions in the negotiations, saying that while he disagreed with some of them at first, the new version of the project is much more viable. Among the special rules put into the rezoning are the price and size limits as well as a requirement that current residents of the mobile home park be given at least three months notice. Veridia's David Bell said he intends to go all out to help residents relocate, including providing ample notice and the first month's rent for their new homes. Residents will also be given the option of keeping their homes if they have a place to move them. Bell said consideration had been given to upgrading the facility and keeping it a mobile home park, but that too much of the infrastructure was in disrepair and many of the trailers were far too old to fix up. He said he did not think the group could have gotten financing to upgrade the park in this market. Several board members urged a reconsideration of the project's parking plan, which provides 68 spaces for the 39 homes.



for cross vine

rossing the Haw River in Saxapahaw last week, I glimpsed the flowers of cross vine, Bignonia capreolata, hanging in treetops where they reach for sunlight. Those vines were at peak flower a week or more ahead of the ones scrambling on my deck.

Bank to foreclose on Greenbridge Developers say sale could prevent it

After months of speculation, Bank of America said Tuesday that it would foreclose on the Greenbridge develop-

ment on June 27. But Tim Toben, one of the 217,000-square-foot project's developers, believes he and the other developers can avoid foreclosure.

"We are confident that we can close on a sale or equity investment from one of our five bidders before that time," he said.

The developers have been in contact with three potential buyers to purchase the remaining \$29 million loan on the \$58.5 million residential and commercial project - valued at \$41.5 million in August 2010 - as well as two possible equity investors to cover construction overrun costs and enable contractor liens to be lifted.

The trouble started last summer, when construction costs ran over and developers requested a loan increase from Bank of America. According to Shirley Norton, a representative of the bank's public relations division, Bank of America approved that loan increase, but when the overruns continued, the bank requested a \$1.6 million equity deposit. According to foreclosure documents filed by the bank, the developers failed to pay that deposit. Toben said the bank refused to pay the contractor's final invoice, and contractor Weaver Cooke Wilson and various construction-material suppliers filed about \$7.9 million in liens on the development.

Commissioners, school boards point finger at Raleigh

The Orange County Board of Commissioners and the boards of both county school systems agreed on Tuesday that the majority of the budgetary issues they face for the coming year are not local, but coming down from state legislators in Raleigh.

The boards of education of Chapel Hill-Carrboro City Schools and Orange County Schools presented their budgets to the county commissioners, and both boards painted a bleak picture.

Steve Halkiotis, a member of the Orange County Schools Board of Education and a former county commissioner, said the schools' only option was in local government.

"I'm going to thank you in advance, because I know that you're going to do the right thing," he said. "If we were to cut you open right now, we'd find a heart inside of you, and not cold ice water like some of those people sitting in Raleigh.

"It's going to be up to us to change some of those mentalities in Raleigh any way we can. We have to outlive them, we have to outthink them, we've got to wear them out, wear them down," he continued. "We love Orange County, and we care about the children of Orange County."

Council flips on OWASA's Jordan Lake plan

CHAPEL HILL — The last time the Chapel Hill Town Council took a vote on a request by the Orange Water and Sewer Authority to modify a key governing agreement for its boundaries and water-supply plans, it was late, and the debate was abbreviated.

At its meeting Monday night at Town Hall, the council's reconsideration of its Feb. 28 approval of the modifications took much longer and resulted in a reversal, denying OWASA approval to formally seek its state allocation of water from Jordan Lake.

The utility says it needs to more aggressively pursue a 5-milliongallons-per-day allocation from the state or risk losing it. The water would be used in the event of emergencies and to stave off tightening water restrictions during droughts.

The move by Chapel Hill follows Carrboro's decision March 1 to change the wording of the proposed new language for the joint Water and Sewer Boundary Agreement to allow Hillsborough and Orange County to draw water from Jordan Lake, but not OWASA.

At the time, members of the Carrboro Board of Aldermen called on Chapel Hill to reconsider its vote, saying the decision to use Jordan

Lake water ran counter to years of water policy and agreement within the community to seek sources within the local purview.

At Monday's meeting, council member Sally Greene recalled the community's longstanding wariness toward Jordan Lake, reading from an interview with the late Joe Herzenberg, a council member who championed the policy of a locally controlled water supply.

Among other things, Herzenberg said concerns about the quality from Jordan Lake's water made it hard to find any local officials willing to drink water from it.

Despite racks for bicycles and easy access to bus routes, board members said the parking would likely prove inadequate.

Board member Jacquie Gist said she understood the intent, but, in a thinly veiled reference to the troubles at Greenbridge, she said the market may force Veridia to change its thinking.

"It's not that I don't get it," she said, adding that there have been "really, really green" developments that just didn't sell.

In other action Tuesday night, the board approved a new section of the town's land-use ordinance that would prevent subdivisions from placing restrictive covenants on energy- and water-saving devices such as rain barrels, clotheslines and solar panels.

The new rules are the result of a successful push in 2009 to modify the town charter to allow for adoption of the new rules.



The Instro Summit will be held at The Cave Friday, April 29 through Sunday, May I.





Hospital ground broken

On April 20, UNC Hospitals hosted a groundbreaking ceremony for a new hospital and physicians' office building in Hillsborough.

Expected to be complete by 2015, the facilities will include 50 acute-care beds, an 18-bed intensive care unit, six operating rooms, two procedure rooms, an emergency department and outpatient medical and surgical specialty services, including urgent care, imaging and oncology.

The campus is located on Waterstone Drive near I-40/I-85 Exit 261, across the street from Durham Technical Community College's Orange County campus.

Among those on hand for the groundbreaking were U.S. Rep. David Price, UNC Health Care System CEO and Dean of the UNC School of Medicine William L. Roper and Hillsborough Mayor Tom Stevens.

The project is estimated to cost more than \$200 million. The hospital and office building will employ approximately 500 people.

ALERT operation

The multi-agency Alcohol Law Enforcement Response Team conducted a compliance operation on April 21. The team, comprised of officers with the Carrboro Police Department and an underage person, checked alcohol outlets in Carrboro for compliance with alcohol-sale regulations.

Detours on Umstead Drive

Beginning in early May, Umstead Drive between Martin Luther King Jr. Boulevard and Umstead Park will be closed to through traffic for about seven months for an OWASA sewerreplacement project. Chapel Hill Transit will implement detours on the following routes: A, N, Saturday JN and Saturday T.

The detours will increase travel times for customers in the affected area and result in the closing of bus stops along Umstead Drive, Pritchard Avenue Extension, Longview Street and Bradley Road. EZ Rider service will not be affected by the project.

Additional detours and stop closures are likely as the project progresses beyond Umstead Park.

CARRBORO — CVS Caremark has filed for a conditional-use permit and a rezoning to allow it to build a new drugstore and commercial building at the corner of Greensboro and Weaver streets.

The long-anticipated filing triggers the town's formal review of the project, which would include a 26,300-square-foot building and parking area on land currently occupied by a former bank on Center Street and the offices of dentist Debra Seaton.

Marty Rupe, a planner for Carrboro who has been monitoring the project, including the contentious discussions at meetings between downtown residents and CVS's developer, Reddlands Inc. of Franklin, Tenn., said the plans will be reviewed by the town as well as officials with the state Department of Transportation and others. This week we respond to questions about knee injuries and TMJ.

Dear HOUSE Calls, I'm in my 20s and I tore my ACL and MCL and got an avulsion fracture of my tibia. Who is the best doctor for my surgery?


We're so sorry. Let's explain what you already know for our readers. The ACL is the anterior cruciate ligament and the MCL is the medial collateral ligament. These are two of four essential stabilizing ligaments for your knee. If you lose one, you may be OK; but without two of these, your joint will be unstable. An avulsion fracture is when the ligament pulls off a part of the bone - in this case, the front bone in your lower leg. There are a lot of great doctors in this area and we don't have a specific name for you. You have great choices at UNC, Duke and in private practice. You may want to look for a knee specialist. Also, this sounds like a sports injury. If you are a serious athlete, you may want an

The absurd GOP spin machine

The closer the dreadful House budget moves toward passage, the more hypocritical those supporting it sound and the more they trot out stale, tiresome talking points and misleading characterizations of the state financial situation to defend their proposal.

As the budget subcommittees approved pieces of the budget this week, the Republican spin machine hit overdrive, most notably about health and human services.

Republicans want to slash more than \$800 million from the HHS budget, which would reduce or end services to thousands of the most vulnerable people in the state, but you'd never know it listening to the two co-chairs of the HHS budget committee, Rep. Nelson Dollar and Rep. Justin Burr.

Dollar and Burr said they were proud of the budget and that it did a lot of good. Dollar pointed out that the plan protects every mental health bed in the state. He neglected to mention that it cuts \$60 million in community mental health services, which would be devastating at a time when the mental health system is staggering to its feet after years of mismanagement and underfunding.

Dollar also boasted that the budget did not eliminate any optional Medicaid services like vision or dental care, but that's an absurd claim that is contradicted in the special provisions the committee also approved.

One provision directs HHS Secretary Lanier Cansler to take whatever action is necessary if projected savings aren't realized and specifically mentions ending optional services. The budget calls for a series of vague unrealistic savings, making it almost certain that Cansler will have to slash services to make up the difference.

Dollar knows better, or ought to. Equally misleading is that neither Dollar nor Burr mentioned in their rosy description of the disastrous budget that the \$700 million in Medicaid cuts over the next two years will actually reduce Medicaid funding in the state by \$2.1 billion, since the federal government provides a 2-to-1 match for state Medicaid dollars.

And the spinning was hardly limited to human services. Republicans were either praising the budgets their committees passed or blaming the cuts on things beyond their control.

Typical of the GOP spin was a tweet by Rep. Carl Horn defending the crippling reductions to the criminal-justice system that one judge called the most devastating thing to hit the court system since hurricanes Fran and Hugo.

Horn said that good programs were unfunded be-



Taxes matter to North Carolina's future

Now that you've filed your income taxes, it's worthwhile to remember what you have pooled your resources to invest in – the public structures that keep us safe, promote healthy communities and provide opportunity for all. These structures serve as the foundation of the nation's and North Carolina's economy.

This connection between the taxes state and federal governments collect and the investments they make is easy to forget. But this year, it is critically important that we remind ourselves of the benefits we and our neighbors enjoy thanks to North Carolina's public structures – because they are all in jeopardy.

Currently, North Carolina legislators are considering drastic cuts that would dismantle the state's earlychildhood education system, increase class sizes in public schools, make college less affordable and dismantle protections for workers. Why? Because policymakers refuse to consider raising (or even preserving) the revenue needed to ensure adequate investments that support a sound economy and a healthy society. Instead, they've narrowed their choices to one spending cut versus another. Such a "cuts-only" approach will lead North Carolina nowhere and make the road to and for the middle class difficult to travel.

We in North Carolina need our leaders to create a vision of a shared future, one toward which we can all strive and contribute. Without it, we will continue to exact these annual sacrifices from the most vulnerable people in the state with no plan to avoid more pain in the future. And we will fail to assess the full scale of the damage that we have wrought on people and our state's public structures and account for how these choices will touch future generations.

North Carolina must continue to be a state that invests early and consistently in its children, providing educational opportunities in the early years that can multiply lifetime earnings. We must provide workers with access to high-quality skills training and higher education that enable them to contribute to economic growth and give them the chance to earn family-sustaining wages. North Carolina must ensure that people with disabilities get the support and tools they need eyeglasses, therapy, prosthetics - that can make their daily challenges a little bit easier, and we must care for and protect our elders, providing them with the opportunity to stay in their homes, eat a healthy meal each day and be part of a community of peers. And to ensure that North Carolina's businesses can compete, we must invest in the roads, bridges and ports that bring goods to market, support entrepreneurs with business training and access to credit and ensure that our communities are healthy and deliver a high quality of life.

All of these public investments are currently on the chopping block at the N.C. General Assembly. But, contrary to what many legislators claim, North Carolina does have budget options. Adequate revenue could minimize or even eliminate these cuts.

By combining our resources to serve the common good, like we do on Tax Day and nearly every day throughout the year, we can invest in what matters to all of us – healthy, stable families, businesses and communities that all enjoy the prosperity of a strong economy. By asking all the people of North Carolina to do our part as we are able, state policymakers can ensure

MH/DD/SA waiver a mistake

This letter comes to you from someone who has lived her whole life with cerebral palsy. As a 52-year-old self-advocate, and teacher of self-advocacy to people with intellectual/developmental disabilities (DD), I am going to explain, through the writing help of my assistant, my concerns related to the Medicaid 1915 (b)(c) waiver.

Even before this change was suggested, it had become a growing concern for me that mental health (MH) and substance abuse (SA) were linked with DD. Unlike MH, where management can be found through medication and therapy, and SA, where treatment can bring lasting results, people with DD do not recover; indeed, they progressively get worse. This waiver, in its full title, is a recovery waiver. How does that apply to DD? Please keep in mind that people with autism, a rapidly growing concern for the population of our country, are covered under the waiver as people with DD.

Managed care will not work for people with DD. We have unique problems, which benefit greatly through specialized therapies, which are currently covered, but will apparently be eliminated with the 1915 (b)(c) revision.

People with DD who've never lived out on their own need employment counseling to gain independence and become contributing members of society. They need to know about safe and affordable housing within communities that are friendly and accessible. These are among the important jobs of case managers, who provide in-home, face-to-face assessments of needs with knowledge of their clients' communities. However, it appears that case managers will be eliminated and instead care coordination will be the process for accessing every need. Does this mean that every time I need something I will have to call someone who has no knowledge about my needs and me and I will have to explain my situation or wait for him/her to familiarize themselves with my file? This sounds like a nightmare - especially for the large population of people with DD who struggle to speak! How will they receive the care they need without hours of exasperation? Do these questions help you understand that DD is different from MH and SA and needs to be separated from them and treated according to its own special needs? Please recognize the damage (and personal disasters) that will inevitably follow by accepting this waiver for people with intellectual/developmental disabilities. I implore you to carefully consider the peril you are placing before a population of people with very little voice but tremendous needs. In conclusion, statewide acceptance of the 1915 (b) (c) waiver as it stands is a mistake. It will not help the population of DD; it will hurt us, simply because our health and safety will be sacrificed.

cause lawmakers needed to "put North Carolina on a sound fiscal basis."

In other words, the shortfall made them do it. But as House Democrats pointed out Thursday, that's simply not true. The budget is simply a list of choices and Republicans could have decided instead to leave the 2009 temporary taxes on the books for two more years to avoid cutting off mental health services, decimating environmental protections and firing 8,700 teacher assistants in public schools and 3,200 faculty and staff in the university system.

House Minority Leader Joe Hackney said that the people of North Carolina don't support the draconian cuts, and the polls show he is right.

A Carolina Issues Poll released by N.C. Policy Watch Thursday morning finds that 66 percent of voters would rather leave taxes at current levels than fire the teacher assistants.

They also favor leaving the temporary taxes in place instead of laying off the university personnel or slashing the Department of Environment and Natural Resources by 25 percent.

The people get it. The Republicans clearly don't, and it's not clear that they care what the people think.

Hackney called the House spending plan an extreme ideological budget. He's right, no matter how hard the Republican spin machine tries to convince us otherwise.

Harm to partners must be addressed JULIA BRANT

Intimate partner violence (IPV), as defined by the Centers for Disease Control, is the "physical, sexual, or psychological harm by a current or former partner." The Department of Justice currently estimates that 25 percent of women in the U.S. have experienced IPV at some point in their lives, while the American Cancer Society lists a woman's lifetime risk of breast cancer as 12 percent. That women are more likely to experience harm from a partner than to develop breast cancer is a startling reality, but, despite these statistics, health care providers always screen for breast cancer but rarely for IPV. As a medical student in North Carolina, I have seen first-hand the effects of IPV exposure and I feel that this imbalance is unacceptable.

IPV is correlated with poor health outcomes. Several recent studies found a positive association between IPV and unhealthy behaviors in men and women, including binge drinking and smoking, both risk factors for a number of serious and potentially lifethreatening diseases. Other research has reported that IPV exposure decreases T-cell function. T cells are an essential part of the immune system, and those with weakened T cells are more prone to illness and infection. In addition, there are a number of larger effects of IPV on health, including direct physical injury from assaults, chronic illness related to prior or repetitive injuries and stress, depression, financial hardships, withdrawal from friends and family and loss of spirituality. In 2007, more than one out of every eight homicides in North Carolina was due to IPV. IPV clearly has health consequences, including death.

There is no question that screening for breast cancer saves lives - with mammograms, we can reduce mortality from breast cancer by as much as 30 percent. So why don't we screen for IPV at clinic visits? Screening for IPV is cheap. The most effective screening tools include survey questions - either oral or written. Screening questions can include: Do you feel in control of your life or relationship? Every couple fights - how do you and your partner argue? Do you ever feel afraid of your partner? Successful clinics that screen every patient for IPV do not report feeling pressed for time with the additional questions. Health care providers are in an influential position because they hold a position of respect and trust. Victims have reported feeling that providers can help and that being asked about abuse strengthens their relationships with their health care providers. Even

victims who are not initially ready to disclose IPV have said that knowing someone cared enough to ask them helped them to feel more empowered.

In my own work screening for IPV in clinics, I have seen the need for universal screening and the benefits in my patients. However, the long-term benefits and the effects in a larger population are still unknown, because there has not been much follow-up of patients who received intervention services after screening positive. Many physicians worry that screening without knowledge of what to do next - after a patient admits to being a victim of IPV - may cause more harm than good. I would agree. In medical school, we are taught not only to recognize risk factors and disease states, but also how to treat. If we are going to successfully help patients who are affected by IPV, we must be able to follow-up our diagnoses. Screening is only the first step. I believe that the long-term benefit to universal screening will be seen once providers receive proper education about referrals and resources so they know what to do for a patient who has experienced IPV.

Many clinics in North Carolina offer screening, but are not connected to local resources. Most providers do not feel comfortable once the IPV "can of worms" is open. I believe that this will change if North Carolina provides IPV education for all the state's health care providers. Kentucky requires all of its physicians to receive three hours of domestic-violence education for medical licensing. In just three hours of training, there was a significant difference in the comfort of Kentucky pediatricians to offer support and planning resources to victims of IPV compared to pediatricians from other states. Physicians never seem to have enough time, but the time required for this training is minimal. The benefits for the victims can be substantial and ultimately may save time and reduce health care costs in the future by reducing hospital visits and poor health outcomes.

Given the prevalence of IPV in the U.S. and its negative health effects, I call upon health care providers in North Carolina to take a stand and advocate for mandatory provider IPV training and education and universal screening for IPV in all clinics. I am not asking them to fix the problem, but to continue to do our duty to relieve suffering and save lives and be an activist for our patients' health.

Chapel Hill-Carrboro has requested \$36.6 million in county funding for 2011-12, which represents the same funding level as 2010-11, but an increase in per-pupil funding from \$3,096 to \$3,126. The request also assumes that the special district-tax rate - specific to Chapel Hill-Carrboro – will remain at 18.84 cents per \$100 of valuation, and that the assessed value of the district tax base will increase by 1 percent, resulting in \$18.7 million in revenues, an increase of about \$100,000 over 2010-11.

Orange County Schools has requested about \$23 million in county funding for 2011-12, a slight increase from 2010-11 funding levels of \$22.8 million.

The state House has proposed an 8.8 percent reduction in funding for K-12 public education, which would mean a \$5.5 million loss for Chapel Hill-Carrboro and \$3.3 million for Orange County Schools. Both districts may also face hundreds of thousands of dollars in increased workers' compensation plans, as well as losses in Smart Start and More at Four funding.

In addition, state legislators have proposed the elimination of teacher assistants for grades two and three.

Both boards have identified potential major reductions in staffing and programs as they brace for state and federal budget cuts. The boards also plan to tap into available fund balances to bear some of the weight of the cuts.

Members of the three boards also discussed the quarter-cent sales-tax referendum that will be on the November ballot. The county commissioners voted earlier this month to dedicate 50 percent of that funding to education and 50 percent to economic development, should the tax be approved by voters.

Commissioners asked school board members to develop prioritized lists with specific projects that would be funded by the tax, which failed on the November 2010 ballot.

"There was a sense that our commitment was a little fuzzy, and it was a little hard for people to understand what this money was going to be used for," Commissioner Steve Yuhasz said. "It's really up to the school boards to provide us with the information that we need."

Since Toben and the other developers sunk everything they had into Greenbridge, they're adjusting their lives to be simpler, he said. He wants to focus on local energy efficiency and policies to support local farmers and food production.

"That's the kind of thinking that we need to get back to,' he said. "The more that I think we can move towards what we want, the more equipped we're going to be to deal with these economic shocks." As for Greenbridge, Toben believes the project will ultimately be fine. "Three to five years from now," he said, "it's going to be a

COWASA officials tried to persuade the council to approve the plan, citing concerns that without the official allocation they could be left high and dry during a drought.

Asked for proof that the state may take away the allocation, Ed Holland, OWASA's chief planning engineer, said he was told in a recent meeting with state water-resources officials that because OWASA's customers had done such a good job conserving, it would be hard for OWASA to justify its allocation. He said it would be a shame for the community to be punished for doing the right thing.

OWASA Director Ed Kerwin said seeking the allocation during the state's current round of reviews of the Jordan Lake water allocations is going to be key to securing OWASA's share said. for the future.

Greene said the water should be a backup source for a true emergency. She said OWASA's plans to use the Jordan Lake water prior to declaring a water emergency and not as a last resort were troubling.

"It should be a backup, a backup source for a true [watershortage] emergency, not a bottom-line emergency," she said.

Representatives of the university and the business community called for approving OWASA's plan.

Carolyn Elfland, UNC's associate vice chancellor for campus services, said greater watersupply diversity is needed. She said there was concern about what would happen if the university's new reclaimed water system went down during a drought. The cost of replacing that water with potable water at the higher prices OWASA charges during water emergencies could represent a real hardship for the university, Efland



The pieces fell into place, and by April 2008 construction had begun. Bank of America approved the developers' \$43.5 million loan in July 2008, but not before a lastminute request that the group increase their down payment from \$8.65 million to \$15 million.

"That was breathtaking for us," Toben said. "We had been

Estes. "I think the whole project went about as smoothly as any project of that magnitude could."

However, changes were made to the development throughout construction, and "any time changes are made, costs go up," Estes said. "There were clearly some engineering issues with the project, particularly the plumbing side of it."

Of the 60 units the developers had contracts for in July 2008, 37 closed, eight backed out and 15 remain under contract. Today, those 37 units remain the only purchased properties in the 97-unit development.



Each year, the department nominates teachers in the field who have worked with student teachers in their discipline to honor them for outstanding work and service in helping teacher education.



Sounds like a practical horticultural guide. "This is assuredly no dry or abstruse study; it is a perpetual spring of the most genuine satisfaction. Even when cares and troubles assail the mind, and overshade all things with gloom (and no one is always exempted from such things) even then let us look at these beauties – let us contemplate them. Yes! We will 'consider the Lilies how they grow.' Our Divine Saviour himself commands us to do it, and never did He enjoin anything which was not for our truest felicity."

And definitely an invitation to nourish the inner spirit through gardening.

"We have only to add that our most esteemed and very particular friend, Mr. George Cooke, has devoted his talents (already so well known to the public) to this work. We are sure nothing more need to be said about its execution."

And, finally, an appreciation for the volumes' illustrator.

George Cooke's hand-colored copperplate engraving appeared in Vol. VIII in 1823 accompanied by the following description:

"A native of woods on the banks of rivers and lakes from Virginia to Florida. It is an elegant climbing plant, and although it will

stand our usual winters in a defended place, out of doors, is yet seen to best advantage planted in a conservatory, in which situation we have had it for several years. It flowers beautifully in May and June. The soil should be loam and peat. It may be increased without much difficulty by cuttings and layers."

It needs no such "defending" here in its natural forest, where one generally sees flowers only after they have fallen to the ground from sunny treetops. However,

some keen local gardeners have brought cross vine down to eye level on arbors or trellises.

While there are horticultural selections, I prefer the naturally occurring bi-colored beauty, so brilliantly captured by 19th century botanical illustrator George Cooke.
