### Occoneechee, our biggest little mountain

Among several little mountains scattered about the county, the tallest, at 867 feet, occupies Occoneechee Mountain State Natural Area near Hillsborough.

For folks out for a vigorous walk, there are several miles of up-and-down terrain to satisfy the most active. For those who enjoy poking along to see what one can see, several hours can pass by quickly.

It's the most biologically diverse natural area in our region with several rare plant and animal species identified by the N.C. Natural Heritage Program. From the high dry (xeric) Chestnut Oak Forest to the Piedmont Bottomland Forest, there are at least seven distinct plant communities, including extensive mountain laurel thickets so evident in the winter, and a lush fern glade evident spring through fall. Whenever one explores the mountain, there are multiple discoveries to be made along the way. During the warm months, butterfly enthusiasts will be eager to spot brown elfin butterflies that feed on huckleberries and lowbush blueberries, as well as the sleepy duskywings that feed on leaves of the chestnut oak. Both of these little brown butterfly species are unusual for this area. You can count on the mountain laurel being in flower every Mother's Day weekend. My favorite time of year on the mountain is winter because it's fully visible. Rock boulders scattered atop the summit and ridges invite exploration. Resting

## Johnny's to reopen soon; neighbors concerned

Nearly six months after Johnny's closed, one of the property owners and two partners are hoping to reopen it, but neighbors are concerned about what form the local store and gathering place might take.

Johnny's closed on June 23 after owners Brian Plaster and Jan Halle parted ways. Plaster said at the time that he closed the business because he ran into issues with noise and parking as Johnny's became a popular gathering spot, but Halle said she hoped to reopen it without Plaster.

She has since partnered with locals Erica Eisdorfer and Kevin Morgan, and the three hope to reopen Johnny's by Christmas, Eisdorfer said. In a conversation earlier this fall, Halle said she hoped to be able to continue to sell beer and wine for on-site consumption, but that town staff had told her she would need to seek a rezoning in order to do so.

Tonight (Thursday), Halle, Eisdorfer and Morgan will go before Carrboro's advisory boards for a preliminary

## Awakening to what life's about

This is the first in a three-part series on the onset of psychosis in young adults, its treatment and UNC's Outreach and Support Intervention Services program.

"My heart and brain are in concert," David Binanay says. But there was a time, not so long ago, when Binanay felt as if cleaved to his core. Such is the nature of his illness.

The road on which Binanay, 28, has traveled has been switchbacks and straight ahead, then around again and on. It started out rough: a congenitally troubled heart. He endured four open-heart surgeries, the first while in preschool, before graduating from Cardinal Gibbons High School in Raleigh in 2001.

But that was just a thing, the heart trouble, something he was born to live with.

"I never was afraid," Binanay says. "My mission was to survive."

He survived and thrived – became class president, school president, top of his class, a talented violinist. He attended Villanova University, where he made dean's list and was elected vice president of his fraternity while earning a degree in the humanities.

His senior thesis was titled "I found a continual aesthetic

experience through music, and through music I've discovered the meaning of life, which is to love."

Binanay returned to the Triangle in 2006, joined a band and took a job at Chapel Hill Violins.

But then it all went haywire, and in a great big hurry. In writing his thesis, he'd studied a number of philosophers, and remembers an analogy equating life with being at sea, amid a fog, "and there are two ways you can take it," he says. "You can be really scared, or you can hear the soundtrack playing, and be, like, this is an amazing

## IFC, TABLE split from PORCH

In order to make people aware of their ongoing need for donations, the Inter-Faith Council for Social Service (IFC) and TABLE have decided to disassociate themselves from local nonprofit PORCH (People Offering Relief for Chapel Hill and Carrboro Homes), no longer accepting its donations.

Citing a change to PORCH's original mission statement and fear of what they perceive as mounting confusion from the public about the level of donations IFC and TABLE require, the two nonprofits decided in early November to remove themselves from the list of groups that

PORCH serves. "We need people to know that TA-BLE is a separate organization with a separate mission," said Joy MacVane, executive director of TABLE.

"We are very glad to have received food from PORCH, but for our organization and programs to stay sustainable it is essential that we receive direct support from the public," she added.

IFC Executive Director Chris Moran said that he too didn't want supporters

## Hearing set on phoning-while-driving ban

CHAPEL HILL – A ban on cell phone use while driving is still a possibility in Chapel Hill.

The Chapel Hill Town Council voted 6-2 on Monday to set a public hearing on a draft ordinance for such a regulation. Council members Laurin Easthom and Gene Pease voted against the measure, citing concerns regarding enforceability and preemption. Council member Matt Czajkowski was not present at the meeting.

Town Attorney Ralph Karpinos

presented a draft of a possible ordinance, which would prohibit the use of cell phones or any additional technology, like cameras or music players, while operating a car. The ordinance proposes a \$25 fine for violation.

The ordinance would not apply to drivers using a phone to communicate with emergency officials in an emergency situation or to drivers communicating with their parents, children, legal guardians or spouses.

In addition, a driver could not be cited for violating the ordinance unless an officer had cause to stop the driver for a violation of another law. For example, a driver could not be stopped simply for using a cell phone while driving, but a driver who ran a stop sign while using a cell phone could be cited for both the traffic violation and using a phone while driving.

Karpinos said he included the exceptions in the proposed ordinance because he felt that would give it a better chance of being upheld if challenged. At issue is whether the ordinance could be preempted by state law, Karpinos said, adding that he felt he could make a reasonable argument against preemption.

## Lovette goes to trial in Carson murder case

Proceedings began Monday at the Orange County Courthouse in Hillsborough in the State of North Carolina v. Laurence Alvin Lovette Jr., who is accused of murdering UNC Student Body President Eve Carson on March 5, 2008.

Lovette is also charged with felony larceny, armed robbery and first-degree kidnapping. However, because Lovette has pled not guilty to all four charges brought against him, Judge Allen Baddour made sure to remind the first pool of jurors to be interviewed that he is presumed to be innocent on all charges.

"Just because he has been charged with a crime does not mean he is guilty," Baddour told the potential jurors. Karen Bethea-Shields, one of Lovette's attorneys, also stressed that her client was

innocent until proven guilty, and said that what was truly on trial was the evidence presented by the state. Bethea-Shields and fellow defense attorney Kevin

Bradley said they Laurence Lovette wanted to make certain that the second murder Lovette has been charged with, in Durham, is not a factor in this trial.

Abhijit Mahato, a Duke University graduate student, was found with a fatal

gunshot wound to the head a two months before Carson was killed. Lovette wasn't charged with the murder of Mahato until after being arrested in the Carson case.

On Monday, defense attorneys told Baddour they believe some of the witnesses Orange County District Attorney Jim Woodall may intend to use in the case will give testimony including information regarding the Mahato case.

While Woodall doesn't deny that five of his potential witnesses will give testimony related to the Mahato case, he argued that their testimony would help show similarities between the two murder cases, such as the nature of the crime and the motive.

## HOUSE Calls

This week we respond to questions about toe injuries and flu shots.

Dear HOUSE Calls, Last week I smashed my big toe. I don't think I broke it, but it looks like there is blood trapped under the nail. Will this resolve on its own?

Ouch! The fancy name for this problem is a sub-ungual hematoma. If the hematoma is big and painful, we can relieve it by piercing the nail with a cautery instrument or a hot needle. If it does not hurt much, you can just let it run its course. It may take a month or more to resolve, and you may lose the nail, but it is not dangerous. Of course, we can't comment on the injury to the toe. Most toe fractures heal without incident, but sometimes big toe fractures need more care, so see your doctor if there is any doubt.

had chest and sinus congestion for a week. Do you think I got a bad shot?

That is a really common question about flu shots. First of all, the flu shot only protects us from influenza. Though what you have might be the flu, it is more likely a garden-variety viral infection (like an adenovirus or rhinovirus). That does not mean it's not miserable, just that it's not the flu. Flu is typically characterized by fever, dry cough and muscle aches. Flu is more likely to result in complications like pneumonia or even death than these other viral infections. That is really the main reason we encourage flu shots. Second, you should know that not all flu shots cover or match with all strains of the flu. Infection experts study trends in circulating flu strains and make predictions six to 12 months before flu season as to what are likely to be the most common circulating

season. These experts are right most of the time, but not always, and there are always less-common circulating strains. Lastly, not all people will develop a robust immune The immune response tends to be better if you have received the vaccine in the past. So the short answer to your question is no, we doubt you probably don't have the flu. Good for you for getting your flu shot and protecting you from the flu.





#### Suspect arrested for indecent exposure

The Carrboro Police Department have arrested and charged Charles Alexander Galloway with six counts of felony indecent exposure to a victim less than 16 years old.

Galloway, from Chapel Hill, was arrested on Nov. 23 after two teenage girls filed a report with the police on Nov. 3 that a man

Charles Galloway had exposed himself multiple times to them while they waited for the school bus. One of the victims gave police the suspect's license plate number, which is what led police to Galloway.

He was released after posting a \$3,500 bond.

#### Shooting/break-in in Chapel Hill

Chapel Hill Police are looking for three suspects in connection with a break-in and shooting that happened on Tuesday.

Officers responded to a call around 6 p.m. about a shooting and break-in at 104 Jackie Robinson St. and upon arriving at the scene found the victim in his home with a single gunshot wound to his leg. The victim said he came home and found three men inside his apartment. The suspects fled the scene and fired one shot in the direction of the victim, which struck him in the leg. He was taken to UNC Hospitals with non-life-threatening injuries.

The three suspects have been identified as tall, black males wearing dark clothing. One suspect has been described as having dreadlocks and was wearing a burgundy coat.

#### Chatham delays revaluation

On Nov. 21 the Chatham County Board of Commissioners decided to delay a property revaluation from 2013 until 2015.

## CH postpones food truck vote

CHAPEL HILL – Citing concerns about enforcement and funding, the Chapel Hill Town Council on Monday again postponed a decision on a proposed food truck ordinance that would allow the trucks within town limits.

Last month, the council opened a public hearing on the proposed regulations, which the council directed staff to develop in May. The discussion stems from a petition last year by Lex Alexander, owner of 3Cups café on Elliott Road, that the town change regulations to allow food trucks.

Town planner Kendal Brown told council members that allowing food trucks would not guarantee a tax-revenue stream and that staff have not yet determined the costs of enforcing regulations, though the town could recoup a modest amount of funding from permitting fees.

Under the regulations, mobile food vendors would be required to pay sales tax on sales made in Orange County, though staff have said that could be difficult to enforce, given the transient nature of the trucks.

"Food trucks are not an 8-to-5, Monday-through-Friday operation," Town Manager Roger Stancil said. "If we are going to enforce anything that you adopt, then we need to have 24-hour coverage seven days a week."

That enforcement, Stancil added, would need to be funded by the town's already stretched budget.

Council members asked staff to look into raising the suggested fees for mobile food vendors, which as proposed total \$118.

Council members said they felt that food trucks could add to the vibrancy of downtown.

"We have some amazing restaurants on Franklin Street, but we don't have duck fat-fried potatoes on Franklin Street," council member Donna Bell said. "I think that there are spaces for us to have new food experiences."

Bell added that food trucks could help fill in the spaces unoccupied by businesses to encourage pedestrians to explore farther along downtown streets.

Jody Argote, owner of Parlez-Vous Crepe, encouraged the council to allow mobile food vendors in Chapel Hill.

"I faithfully pay my annual sales tax, as do all of the other food truck vendors that I know," she said, adding that because her business is unique, she draws in customers from other areas, who might then spend money with other businesses in Chapel Hill.

Katrina Ryan, owner of Sugarland Bakery on Franklin Street, said she felt that food trucks wouldn't add anything valuable to the already rich local-food scene.

"There are no local jobs created, there isn't any financial ben-

#### efit to the town, so I don't see any upside," she said.

The draft ordinance proposes allowing food trucks on private, commercially zoned lots, subject to approval by the property owner. Food trucks would have to be at least 100 feet from the customer entrance of a restaurant during its hours of operation and could not provide seating.

In the downtown area, trucks would only be allowed to operate in lots with at least five parking spaces and an existing business in a permanent building, while the business is closed. One truck would be allowed per 1,500 square feet of parking lot.

Outside the downtown area, trucks could operate while the existing business is open and trucks would be limited to one vendor per acre or per 30 parking spaces.

The council will revisit the ordinance at a public hearing on Jan. 23.

## **BOA** approves E. Main sewer

CARRBORO – At its Nov. 22 meeting, the Carrboro Board of Aldermen unanimously agreed to pursue the construction of a public sewer line on East Main Street.

The town has sent a letter to the Orange County Board of Commissioners seeking assistance with funding for the new line, which is estimated to cost \$250,000.

On Aug. 26, a private sewer line began to discharge sewage in a parking lot behind businesses on the 100 block of East Main Street. A temporary fix was made to the line, and owners of property on the south side of the block of Main Street from Armadillo Grill to Friendly Barber have been working to fix the problem, but without a long-term solution the issue could force the closure of the

restaurants and bar on the block. Because the line in question is a private line, OWASA policies state that the utility is not responsible for maintaining it, leaving prop-

erty owners responsible for the fix. The board has already approved the use of \$60,000 from the town's revolving loan fund to repair the line, but property owners ran into issues with the repair, which would require crossing over the property of Jean Ward, who owns the building that houses Friendly Barber and the Orange County Social Club. Town staff have not been successful in negotiating an easement over the propertv.

## **Carrboro apologizes** to Yates detainees

CARRBORO – The Carrboro Board of Aldermen last week voted to issue apologies to the reporters and bystanders who were detained in the Nov. 13 police raid on occupiers of the Yates Motor Co building.

Concerns have been raised about the police's response to the occupation, which began the night of Nov. 12, led, reportedly, by attendees of the Carrboro Anarchist Bookfair, and resulting in a dramatic encounter with police the next afternoon, with seven ar-

Residents have questioned the police's failure to attempt to communicate with those inside the building prior to the raid, in which police brandished longrange rifles and detained those on the sidewalk outside the entrance

of the building - including two journalists - before rushing inside.

In accordance with Carrboro's mutual aid agreement with Chapel Hill, Carrboro police assisted Chapel Hill police in the operation. The board voted unanimously to apologize to the detained reporters, and voted 4-3 to apologize to detained uninvolved persons outside the building. Board members Joal Hall Broun, Jacquie Gist and Lydia Lavelle voted against issuing the second apology, saying they preferred to wait until more information became available.

The Chapel Hill Town Council last week voted against a petition by member Laurin Easthom to issue an apology to the reporters, later voting to refer the measure to staff for consideration. - Staff Reports

# 'Geothermal' finish for Tar Heels

North Carolina finished off its second consecutive season of unholy stress in style with a 37-21 victory over Duke at Kenan Stadium in the regular-season finale for both teams.

Freshman runner Giovani "Gio" Bernard burned the Blue Devils for 165 yards and a touchdown

The victory assures the Tar Heels of their fourth straight winning season, and they now have a chance to win an eighth



Eddy Landreth these players and their coaching staff have weathered the loss of eligibility from eventual first- and secondround NFL draft picks because of NCAA violations. The program has been hammered by an NCAA investigation and a string

of internal and external allegations, some true and some false. They even lost their head coach just one week before the start of training camp. The journey might have crippled a lesser group, and when one stands back and looks at the team's body of work, it's difficult not to admire what these players have accom-

plished. "These kids are tough, mentally and physically," interim coach Everett Withers said after probably his final game as head coach at Kenan Stadium. "They mean an awful lot to me. They are resilient. They work their butt off every day. They try to do everything we ask them to do.

"They didn't bat an eye [when coach Butch Davis was fired]," Withers said. "They came to work. I didn't know how they would react initially. When we started camp it was, 'OK, here we go.'

"Once we got about three or four days into it, it was like, 'OK, they're going to respond.' As coaches," Withers continued, "we had to respond because they did. I'm as proud of this football team as any I've ever been on."

The players awarded Withers with the game ball to honor his stepping in to be the head coach under trying circumstances.

The Tar Heels had their tough moments, but overall they refused to let the adversity tear them apart.

"This team and last year's team, there is a great family bond," Bernard said.

Bernard has been impressive all season, never more so than in this game.

"[Bernard is a shifty runner]," Duke coach David Cutcliffe said. "And one of the things with Carolina's big offensive line, if we leave a gap uncontested, it's very difficult for a safety to get in there quick enough to stop a youngster like him. And when they get moving down on people, it minimizes your backer's ability to get to a gap; it minimizes your safety's ability to field.

"I thought they got more movement than most people have against us."

Bernard gained 1,222 rushing yards in 12 regular-season games. His production on Saturday gave him seven 100-yard rushing games this season, breaking the freshman record of six held by Amos Lawrence.

He missed last season with a knee injury.

"Even when I was not on the field last year, I felt that family bond," Bernard said. "That is one of the reasons I came to this school, that family tie. We've done a great job of finishing strong, even through the hard games and the hard losses." The success on the ground helped quarterback Bryn Renner and wide receiver Dwight Jones enjoy one of their finest days together, too.

Renner completed 21 of 34 passes for 274 yards, three touchdowns and one interception. Jones, a senior, caught 10 passes for 101 yards and three touchdowns to finish his career at Kenan Stadium.

"Dwight, for maybe the last month of so, you could see he cherished every day that he has been out there on the field, whether it's been the practice field or game field," Withers said. "Every day he has come to work, it has been, 'I know I want to make sure I give everything because this game isn't promised to you.'

"You could tell that in his eyes," Withers said. "Dwight has become the guy in that locker room. He doesn't say a whole lot, but when Dwight talks, there are a lot of people in that locker room who listen."

The coaching staff moved defensive end Quinton Coples back to defensive tackle, the spot he played last season, and he led a Carolina defense that held Duke to 46 yards rushing.

"We don't have an answer for Coples, obviously," Cutcliffe said. "We saw that."

Coples finished tied for second on the team with six tackles, while leading in sacks with two and posting three total tackles for losses. He also forced a fumble and recovered one.

"It was my last game at Kenan Stadium," Coples said. "I'm a senior, and it's a rivalry, so it's more personal. I think I was more into it mentally."

There was also the matter of finishing with a winning record instead of breaking even.

"It's huge," Withers said. "All we want is the opportunity to win eight. When we stepped into this week, we said, 'Let's win seven,' first things first.

"Now let's see if we get to a bowl and win eight."

The defense attorneys also questioned the credibility of some of those witnesses.

"One of the witnesses swore in front of the federal grand jury something that is totally different than what is given in this sealed admission," Bethea-Shields said. "You have hearsay upon hearsay."

Additionally, Lovette's attorneys said that, given that there may be similarities between the two cases, in hearing information about the Durham case, jurors could get confused.

"We are talking about trying two cases," Bethea-Shields told the judge. "That is what the court is going to do by letting these ... statements come in, and it will be totally confusing to the jury. At some point, they are going to ask, What are we trying?"

Baddour ruled that those witnesses would be allowed to testify and give information regarding the Mahato case, but that the defense would be allowed to argue against the evidence they present and claim it to be inadmissible.

#### Jury selection

In his introduction to potential jury members on Tuesday, Baddour said he anticipates the trial

lasting three weeks.

However, if the pace at which individual jurors were interviewed during the first day of jury selection is maintained, that process alone could take nearly that long. It took almost the entire morning session to question one juror, who, after extensive questioning by Woodall, was determined to be unfit to serve and was dismissed.

Questioning of a second juror began before the court went into recess for lunch, and by the end of the day, only four of the more than 40 potential jurors had been questioned.

review of their application, which has not yet been officially submitted to the town.

According to town planning director Trish McGuire, the property is actually zoned residential, but Johnny's had been permitted to continuing operating there. The Johnny's that occupied the space for many years – a bait and tackle shop – was at one time in line with the zoning for the property, but the zoning changed to residential a number of years ago.

Because the business predated the zoning change, it was allowed to continue operating with previously approved uses - which don't include on-site alcohol consumption - under provisions of the zoning ordinance. However, the ABC license that Plaster received in order to serve beer and wine on site was not reviewed by the town's zoning staff before it was approved, McGuire said.

"It was an inadvertent approval of on-site sales," she said.

According to McGuire, the town had received multiple comments from concerned residents regarding Johnny's. Last week, Tina Saldana, a resident of Westview Drive, which runs alongside Johnny's, presented a letter from 75 residents to the Carrboro Board of Aldermen opposing onsite alcohol sales at the store, citing public-safety concerns.

"The large crowds that came to the location to consume alcohol were a serious public safety hazard in an area of town that was not designed for such a site," the let-

> relief organization that specializes in fighting childhood hunger," she said.

Romaine said PORCH has decided to have a "cooling-off period" of about two months before trying to again talk with the IFC and TABLE, and in the meantime to continue to serve the community.

"This whole food fight among PORCH and IFC and TABLE is taking our eye off the prize," she said. "My hope is that after two months, we will be able to come together and work collaboratively to address local hunger."

to think that PORCH was taking care of all of the IFC's food donations, adding that he felt that PORCH was changing its mission without consulting the IFC.

"More than 3,500 households are benefiting from the food pantry," Moran said. "We are not saying we don't need food, we are simply saying that PORCH is moving in a different direction."

PORCH co-founder Susan Romaine said that since the entirely volunteer-run nonprofit's founding in May 2010, it has been delivering food to the IFC and TABLE, and that it wasn't until very recently that the two groups started voicing their concerns to PORCH.

"On Nov. 8, we received an

email from IFC expressing concerns with how food collections were allocated," Romaine said. "We thought that after the concerns were expressed, all of this would be worked out through an



## It doesn't matter to the GOP that race matters

The most remarkable thing in the Senate debate and vote to repeal the Racial Justice Act (RJA) Monday was that no one seriously responded to the studies cited by RJA supporters that prove race plays a role in who is sentenced to death in North Carolina.

The only conclusion you can draw from that is the one that Sen. Martin Nesbitt drew, that Republican lawmakers know that racial bias infects our capital punishment system and they don't want to do anything about it.

Maybe it's the fear of being branded as soft on crime in the next election. Maybe it is the fear of the political power of their local district attorneys or of alienating their right-wing political base. Maybe it is the unwillingness to face the truth.

Whatever it is, every Republican in the Senate voted to ignore the evidence that race matters in the dolling out of the death penalty.

They tried hard to change the subject, professing their support for the families of murder victims, many of whom came to the Legislative Building to tell their heart-wrenching stories about losing their loved ones to senseless violence.

The Republicans didn't get around to mentioning that the budget they passed in June cuts funding in the court system for services for victims of crime.

Several murder victims' family members told a Senate committee they opposed the repeal of the Racial Justice Act. Many others expressed support for repealing it before the committee and at a press conference earlier in the day organized by the N.C Conference of District Attorneys.

The district attorneys testified for the repeal too, claiming the statistical evidence of racial bias allowed to be presented under the RJA would vacate many death sentences. They wouldn't say why, but it's pretty obvious.

They know the evidence would prove race is a factor in who is sentenced to death in North Carolina. And they don't want to talk about it, much less admit it.

Senate President Pro Tem Phil Berger said on the Senate floor that the Republicans were only reforming the RJA, not repealing it, a disingenuous claim contradicted by the legislature's own staff, who said the bill would take the law back to exactly where it was before the RJA passed in 2009. That is the definition of repeal. The Republicans also predictably used fear to avoid talking about the truth, repeatedly claiming that the RJA would result in convicted murderers being released from prison. It's simply not true. The law says the remedy for death row inmates who prove race played a role in their case is a sentence of life in prison without parole.

## Time to take direct action

Derrick Jensen, author of Deep Green Resistance, asks two questions: What do we want more of in our lives, and how do we get there? We're numb to it, but I'll say it anyway: Our culture is destroying our planet. We watch and participate in the slow poisoning of our children, fed a diet of processed food, processed news and processed education. Few children experience the natural world with the kind of intimacy that we and our parents did.

Richard Louv has dubbed the effects of that schism as "nature deficit disorder." Like Jensen, I want each year to bring more migrating songbirds and fewer incidents of dioxin in mothers' breast milk. So how do we get there? Here also, I agree with Jensen that all options must be on the table. The mainstream environmental movement has failed to slow the industrial juggernaut that puts our planet and the children of all species in peril.

As GDP grows, ecosystem health declines. Because most of us are just trying to pay our bills and support our families, we rarely stop to examine the systemic flaws that govern our actions. The Occupy movement has shined a light on those systemic failures, and I strongly support it.

Until last year, I operated within that system. Mine was one of five local families who came together to create a model green building in Chapel Hill. We met with community organizers, ministers and neighbors, all of whom endorsed the project. We received unanimous approval by the Chapel Hill Town Council and were encouraged to proceed. We hired arguably the leading green architect in the world to design it. It would be a prototype that consumed half the energy of conventional buildings, but like every prototype, it would cost a whole lot more than the second, 50th or 500th one built. Some would not be able to afford to live there.

To finance the project, we signed a deal (aka a "construction loan") with the devil (Bank of America) on July 17, 2008. Three months later, the banks, gambling our mortgages in the great Wall Street casino, tanked the U.S. economy. The federal government intervened with TARP (the Troubled Asset Relief Program), but instead of paying forward that largess, the banks tightened credit policy and crushed commercial projects like ours and foreclosed on families across America.



Sen. Josh Stein suggested the law could be strengthened even more to reassure Republicans that no one would be eligible for parole, but his proposal was ignored.

This debate was never about the facts, the undeniable evidence that people are more likely to get the death penalty if the victim of their crime is white and that blacks are more likely to be struck form jury pools than their white counterparts.

This debate and this repeal of the Racial Justice Act was to pander to a political base and to prevent the criminal justice system from coming to terms with its racially biased procedure for determining who lives and who dies.

Sadly, race does matter in our capital punishment system. Sadder still is that Republican legislative leaders don't seem too concerned about it.

#### SW library shouldn't be downtown

The latest library being cussed and discussed in Orange County is the proposed "Carrboro" library – which is not only an error in name but an apparent misunderstanding of its use and location.

First off, it's the "Southwest Orange Library" - planned to serve residents from Cane Creek and Mebane Oaks Road we (with many, many college students) offer many programs

to the Chatham County line, Carrboro, Chapel Hill, and farther north for those who find the Hillsborough library inconvenient.

Much of the area west of Fayetteville Road and Old N.C. 86 lies in University Lake watershed and is restricted to wells and septic systems with no public water and sewer lines allowed in an effort to limit development and protect drinking water.

So acceptable locations for the new

building are pretty much limited to those with established wathe town will be a long distance from rural residents.

Building sites have been discussed by the county commissioners and the Carrboro aldermen, and the public will have a chance to speak at the commissioners' meeting at the Sportsplex in Hillsborough on Monday at 7 p.m.

The aldermen appear to favor a downtown location - why? Parking and congestion are already a major problem, downtown land is much more expensive and children and families don't live there.

It's interesting to note that the Chapel Hill library, the most popular public library in the state, is built off the road in a residential neighborhood nowhere near downtown, and doesn't have an easy biking, walking or bus route to get there. It does have ample parking and a drop-off box for cars.

Many of us who live in Carrboro feel an almost ideal location for the Southwest Orange Library is the land adjoining Carrboro's Martin Luther King Jr. Park property on Hillsborough Road. It's affordable at \$150,000; parking and development expenses could be shared with the town, reducing costs for both; and it's in a residential area and close to McDougle School with access by sidewalks, bike lanes and buses that run from other sections of town and parts of the rural areas. It would be even more accessible if new rural bus routes were scheduled to come there or to transfer to buses that do.

Finally, after the site is selected, a board of a wide variety of residents should be appointed to work with government in planning and running the building. It's a great opportunity for an energy-efficient, solar-powered design to make this a truly unique, cooperative and educational undertaking. Who characterized their approach to a difficult situation. knows, it could help restore faith in government!

The partners of Greenbridge lost everything we invested. Last fiscal quarter, Bank of America reported a \$6 billion profit - \$2 billion a month.

And while the corporations usurp the wealth of communities, even the "green" movement has been co-opted by industry. The omnipresent green labels on everything from light bulbs to lawnmowers suggest that we are doing a lot to change direction, but the opposite is true. We are an industrial growth economy, driving straight toward the ecological cliff. We've even accelerated, over the past 10 years, from 60 to 65 mph. We have to stop buying stuff. It's going to take a few brave souls standing in the middle of the road risking their lives to slow us down.

Two months ago, I went to Washington, D.C., and participated in the 350.org protest of the Keystone XL Pipeline outside the White House. Like others who think that pumping dirty tar sands oil over aquifers and farmland is nuts, I was arrested and taken to the Anacostia jail. It was a small act of civil disobedience, but a long way from my service on President Obama's National Finance Committee in 2008.

It is time for direct action of every type, and it's encouraging to see more and creative uses of civil disobedience. We are in financial, social and ecological crisis, and I'm grateful to all who are willing to take risks of every sort to fundamentally alter America's direction.

adventure, and I'm surrounded by the fog."

"That's how it had been for me," he says, "an amazing adventure. I would face death and not be scared. There was a fog around me, but I was living the adventure, and loving every second."

Now though, something had happened, and he saw his hands – these hands that so skillfully traversed the violin – for the first time.

"I'd trained myself to be removed, like I was truly adopting nonattachment. Then when I had my schizophrenia, I awoke to my hands."

"I awoke to being, to selfawareness," he now recalls. "I was like, wow, I'm a human being."

Binanay now wonders if the effects of schizophrenia were visited upon him, or perhaps worsened, by "all that pain that was built up from my surgeries. It's just an idea."

Therapists, he says, have told him it's plausible.

## 'The beginning of wisdom'

Schizophrenia translates, roughly, as a "splitting of the mind." It's most commonly first diagnosed in older adolescence and early adulthood. There is no cure, but it's treatable, especially if confronted early.

Binanay had known success his entire life. He'd performed with the Raleigh Boychoir in Carnegie Hall and at the White House, done well in school and been popular.

Now his life was unraveling, and it was terrifying, and exhilarating. It was spiritual. He'd grown up a practicing Catholic. But this was a "heightened spirituality; it was like everything was spiritual, and it was running through all things."

"I didn't know what was happening to me," he says of the first days and weeks of his psychosis. "I was being re-created. ... I went from where I wasn't sensing anything to 100 percent sensory overload. It was like ... it was intense."

He wanted it to stop, and he didn't.

He was institutionalized for the first time. Medication became a part of his life – a source of dispute with his parents – on and off the meds. They dulled his senses, for better and for worse, to his mind.

"Everything that I was seeing and everything that I was hearing was confirming this spiritual experience," he recalls.

But, "I was scared. It was like a baby cries. You don't know why a baby cries, but sometimes you can see a baby's scared because it doesn't know yet. And I didn't know; I didn't know what was going on yet."

Binanay pauses in conversation, and listens. A train whistle's blowing, and it triggers a memory.

"I'd be at a barbershop, and we'd hear a train, and they'd be, like, 'That's an old one.' Like, it's an old spirit.

"In our book, we relate what we know and hear and see – in our book of life. Everything we see, everything we hear, everything we touch, everything we feel – that's my book of life.

"And a sound has the power to evoke."

He'd begun to listen, was hearing things. Not auditory hallucinations; just things being uttered, perhaps in a whisper. He couldn't make out what, specifically, was being said, but, he now says, "there's still some kind of understanding."

#### The world out there

When David Binanay first came to the *Outreach and Support Intervention Services (OASIS)* program, administered by UNC's *Center* for *Excellence* in Community Mental Health, in Carrboro's Carr Mill Mall, he had, he says, the stare – "the psychosis stare."

"I don't know if you've seen many patients, but they have that stare," he says. "I had the stare. When I talked to someone, I could see everything; I could see right through them. My eyes would not turn away, and I could see their shoulders, the weight they were carrying. I could see their eyes. I could see their faces, their auras. It was like a holy moment, completely."

He had awoken, he says, "to the magnificence, to the exuberance that my paper was about" – his college thesis – "and the fog was lifted."

He had awoken to schizophrenia, and had seen his hands for the first time. He was listening, feeling, for the first time.

"I was, like, *whoa*, there's actually a lot out there in the world, and I was scared."

So too were his parents, who stood by him throughout. Compliance with his meds came in fits and starts, and eventually took hold.

"I had fear for the first time in my life," he says, "but they say fear is the beginning of wisdom."

His mind was split open, and he was coming from a place in the heart. His work with OASIS had begun.



on any of those boulders, one will likely marvel at the massive rock chestnut oaks, Quercus prinus, that dominate the forest.

Some of those trees must be up to 200 years old. You'll likely be curious about the contorted appearance of some that have three, four and even five massive trunks radiating from the base. This oak is noted for sprouting vigorously from the ground if injured by fire or harvested for its timber.

The forest floor this time of year is a lovely thick carpet of mostly chestnut oak leaves. Beneath the leaves in some spots you'll find large, 1-to-2-inch-long acorns beginning to sprout a little tap root. Like the white oaks, these acorns are edible and worth the effort to roast a few for winter snacks.

Occoneechee is steeped in history, beginning with the Native Americans who named it. There's an aban-

> doned quarry dating back to the 1880s on one side of the mountain and a present-day active pyrophyllite mine on another side. Curiously associated with the mountain's erosion-resistant quartz rock is the soft phyrophyllite being quarried for the manufacturing of products ranging from soft, fine talcum powder to heat-resistant electrical insulators.

The more than 630-million-year-old geological story of the Occoneechee area is beautifully described and illustrated in the N.C. Geological Survey's nformation Circular 35, A Geologic Adventure Along the Eno River, by geologist Philip J. Bradley. It's a very readable resource. (geology. enr.state.nc.us). In addition to descriptions of rock types and geologic history, the publication contains guides to the geology of four popular trails along the Eno River. I recommend at east monthly explo-

rations of Occoneechee, our highest

Several council members questioned the inclusion of exceptions for drivers to use phones to speak with family members.

"I don't know that I want to make that an exception for someone to be on the phone ... if that conversation is going to impact their safety in driving," council member Donna Bell said.

"If we take the teeth out of it, I'm not really interested in doing it," she added. "We have people who put other people's lives in danger by distracted driving." Mayor Mark Kleinschmidt said he would like for the exceptions in the ordinance to use more inclusive language, "since I might not have a spouse, but I might have an equivalent that I might want to talk to one day." Pease said he felt that while it was important to educate the public on the dangers of cell phone use while driving, regulating it is a state issue, and that such an ordinance would be virtually unenforceable.



"If this is about education, I'm not convinced this is the right forum to do it," he said.

Easthom agreed.

"I don't want to be first in the state on something that the assistant attorney general has said ... is preempted by state law and therefore unenforceable," she said. Earlier this fall, Karpinos requested an opinion from the state attorney general's office, and an assistant attorney general reported back that he felt such an ordinance would be preempted by state law.

Other council members said they felt it was important to continue the conversation and the education of the public.

"This may be an opportunity for this to happen again where Chapel Hill pulls the state along in some things," Mayor Pro Tem Jim Ward said.

In June, Krista Slough, a UNC student who was seriously injured in a car accident last year, and Joe Capowski, a resident who witnessed the accident, petitioned the council to consider the ban. Capowski alleged that the driver of the car that hit the victim was talking on her cell phone at the time of the accident.

Texting while driving and the use of cell phones by drivers under 18 are both already illegal in North Carolina.

A public hearing on the proposed ordinance will be held Feb. 20.
