An Illustrated Record



A Brief History of the 20th Armored Division at Dachau

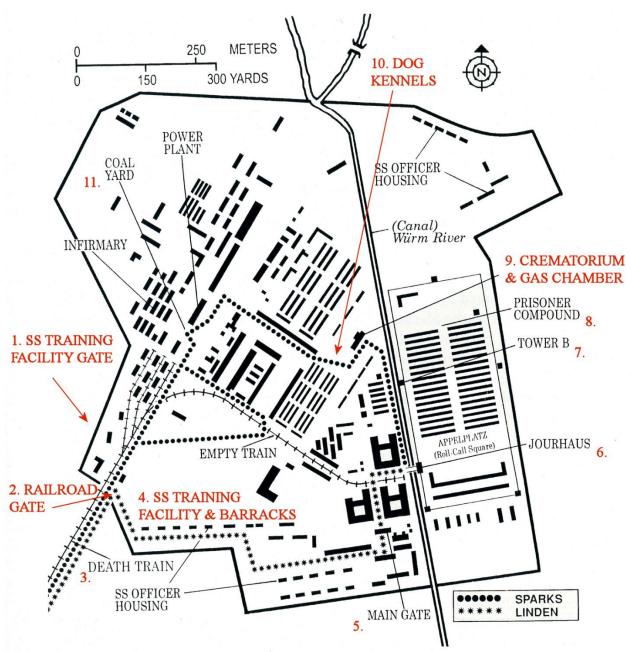
The Dachau concentration camp was not assigned to the 20th Armored Division (AD).

In mid-April, 1945, XV Corps G-5 (Civil Affairs) initially expected the 20th Armored Division to be the first unit to reach the camp. Near the end of April, officers at XV Corps headquarters saw that the 45th Infantry Division (ID) was in the best position to reach the camp first. Combat Commands A and B, 20th AD were operating on the left and right flanks of the 45th.

However, on April 29, 1945 while enroute to their assignments, soldiers of the 20th Armored Division briefly entered Dachau concentration camp. They participated in liberation including witnessing (along with GI's of the 45th and 42nd Infantry Divisions) railroad boxcars containing thousands of dead Buchenwald inmates, the stacks of dead bodies, the crematorium, the gas chamber, the gallows, the bodies of dead SS guards, and the thousands of emaciated inmates. Some shared rations until medics stopped them as the high calories were harmful to the starving inmates. Some took photographs of their surroundings.

Following their visits to the concentration camp (generally reported as 2 hours or less), soldiers of the 20th resumed movement toward their assigned objectives in the next day's Battle and / or occupation of Munich, or toward the Austrian border in pursuit of retreating German forces and a feared national redoubt in the Alps.

Pathways Into & Through the Camp

- 1. S/SGT Wilburn Smith (C CO., 27th Tank Btn., **20th AD**), in a jeep at the unlocked and unguarded west gate to Dachau's SS training facility, **(1)** above. We presume this served a **20th AD** entry point into the camp.
- 1a. Wider view, souvenir photo from the collection of Pfc Felix A. Cizewski 45th Signal Co., 45th Infantry Division.
- 1b. Soldiers of the 42nd ID guard this same gate. (U.S. Army photo via the NY State Military Museum.)



2. At different times, soldiers of the **45**th and **42nd Infantry**, and **20th Armored Divisions**, also entered the SS training facility through the unlocked and unguarded railroad gate, (2) above. Soldiers of the **45**th killed several SS soldiers in the vicinity of the Nazi death train. (*U.S. Army photo via the U.S. Holocaust Memorial Museum (USHMM).*)



3. Each Division's units proceeded past the railroad cars of deceased Buchenwald inmates (ie., death train), into varied parts of the camp's interior. It's believed that the **20**th **AD** traveled the dotted line marked **LINDEN** to the main gate of the concentration camp, **(5)** above (LINDEN was the 42nd ID's onsite Commanding General). The pictured gate has since been demolished. (*Photo from the KZ-Gedenkstätte Dachau website.*)



- 4. Via varied routes, each Division's personnel eventually came to the camp's Jourhaus building, **(6)** above. Photo depicts the International Red Cross (IRC)-arranged surrender of the camp to the **42nd ID**. Standing atop a Jourhaus bridge wall, theatrically directing his troops with a riding crop, is Brigadier General Henning Linden (the **42nd's** Assistant Division Commander). Standing tall at left, SS-Untersturmführer, 2nd Lt Heinrich Wicker (acting camp commander), surrenders the camp. Swiss IRC delegate, Dr. Victor Maurer (wearing a white (red cross) armband, who arranged the surrender), stands between. Troops and inmates clamber at right. Wicker (hastily thrown into camp command, just hours before) didn't survive the day. (U.S. Army photo via the U.S. Holocaust Memorial Museum (USHMM).)
- 5. Through the Jourhaus, (6), soldiers of the three co-liberating Divisions entered the Prisoner Compound ([8] above), and points beyond.



6. At some point, according to investigation by the **Seventh Army Inspector General**, soldiers of 1st Battalion, 222nd Infantry Regiment (IR), **42**nd **ID** and soldiers of the 157th Infantry Regiment, **45**th **Infantry Division** killed an estimated (17) SS soldiers at Guard Tower B, **(7)** above. (*Public domain photo from the National Archives.*)



7. Separately, a small number of soldiers of Co. I, 157th Infantry Regiment (IR), **45**th **ID**, lined up an estimated 75 unarmed & surrendered SS guards in the camp's Coal Yard, **(11)** above. With machine gun and small arms, they killed an estimated 17, wounding numerous others. C.O., Lt. Col. Felix Sparks (Commander, Task Force Sparks, **45**th **ID**) arrived & interceded to prevent further bloodshed (see photo). (*Public domain photo from the National Archives.*)

Before day's end, as many as (50) SS soldiers were killed: approx. (16) in the coal yard, (17) at Guard Tower B, (4) in the train yard, and several others, elsewhere in the camp. Ultimately, no one stood trial for murderous war crimes, as following V-E Day, General George S. Patton (in his then-role as Military Governor of Bavaria) dismissed all U.S. Army charges.

At some point later on this long day, nearing the end of this long war, the **45**th **ID**'s Lt. Col. Sparks and the **42**nd's Brig. Gen. Linden engaged in a heated argument in front of the Jourhaus, **(6)**, over military jurisdiction and command authority.

While Linden & the 42nd had accepted the camp surrender, Sparks & his 45th troops had not only arrived earlier, but (unlike Linden and company) were legitimately assigned the sector by Seventh Army command. Linden's crossing the 42nd / 45th Division boundary not only endangered soldiers of his own 42nd and attached 20th Armored Divisions, but those of the 45th, as well. Earlier in the day, Sparks and his men had come under friendly fire from units of the 42nd. Official radio logs show that not only was the 45th ID, but also XV Corps itself, dealing with the 42nd's inappropriate crossing of Division boundaries, vis-a-vis security, safety, and care of 32,000 liberated inmates.

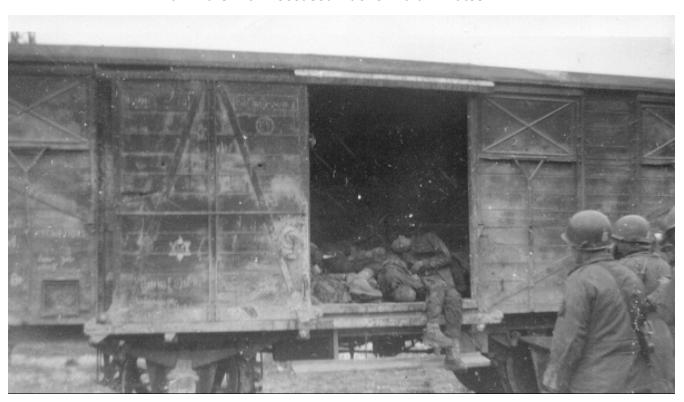
As tempers exploded, an exhausted & weary Sparks pulled his Colt .45 service pistol on the (technically) superior officer, threatening the General, accompanying journalist, Marguerite Higgins, and their media-circus entourage, to withdraw from the camp immediately.

On 1 May, Col. Sparks was relieved. It's unclear if this was over the murders of SS soldiers at the camp, his clash with Linden, or both. Col. Sparks was to rejoin the 157th in the U.S. for their deployment to the Pacific and the war with Japan.

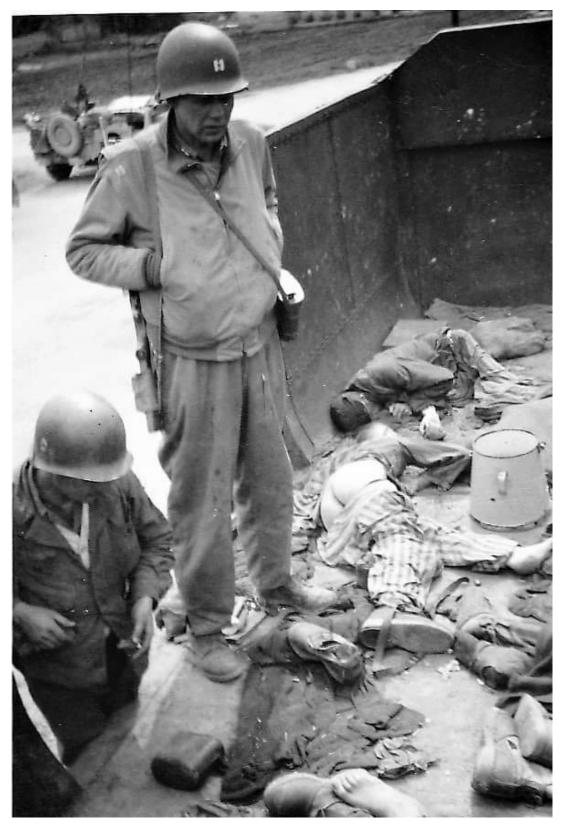

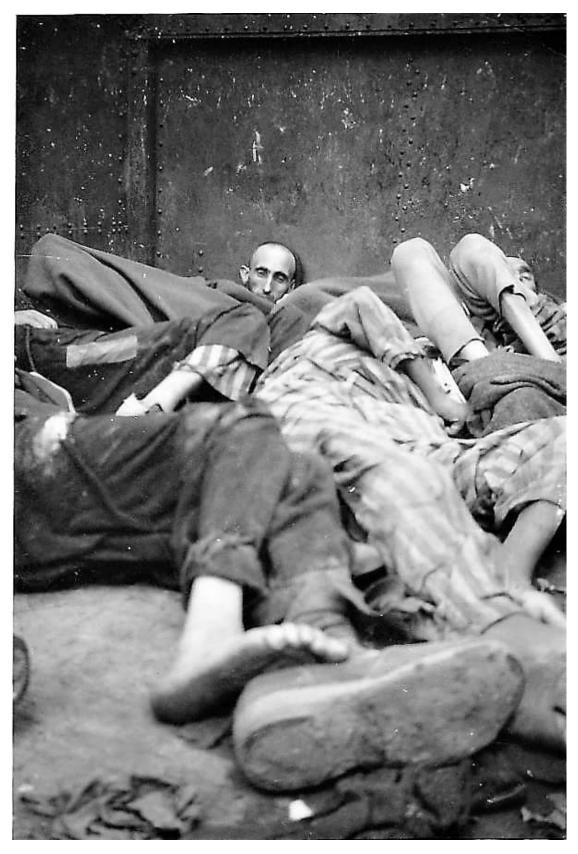

Stacks of Bodies in the Camp Yard



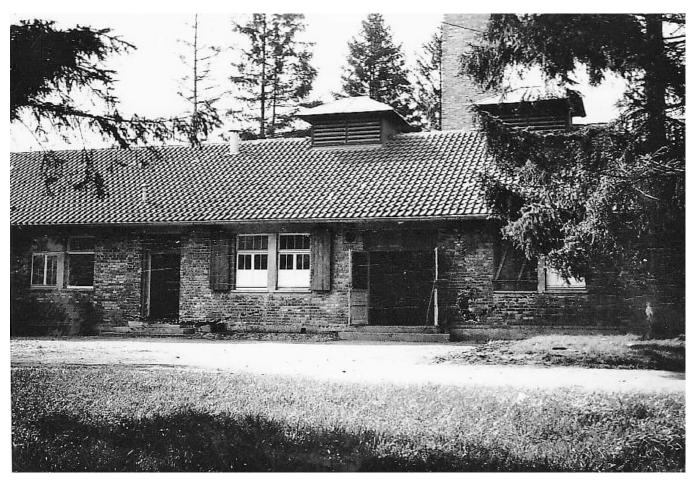
Bodies were stacked outdoors⁽⁹⁾.

The Allied air campaign had caused a shortage of coal. As a result, by February 1945, the crematoria in camps and subcamps had ceased operation for lack of fuel.

Shortly before liberation, the camps effectively ceased functioning. Some of the assigned guards fled. Starved and exhausted Dachau inmates were no longer able to haul by horse carts their deceased comrades to the mass grave site, 2 miles away in Leitenberg.

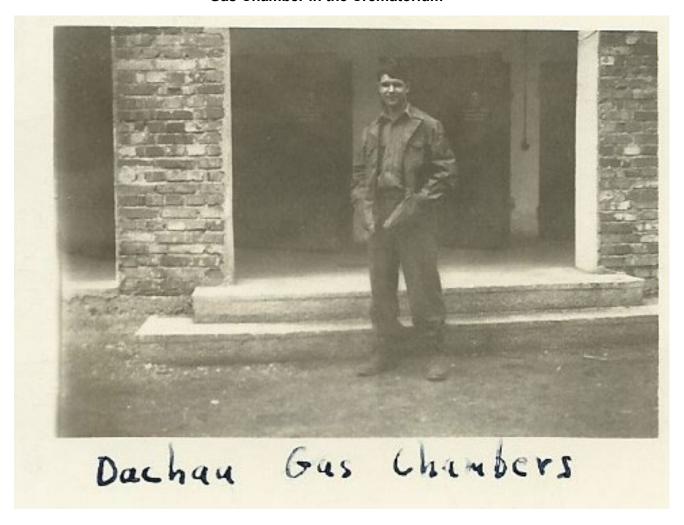

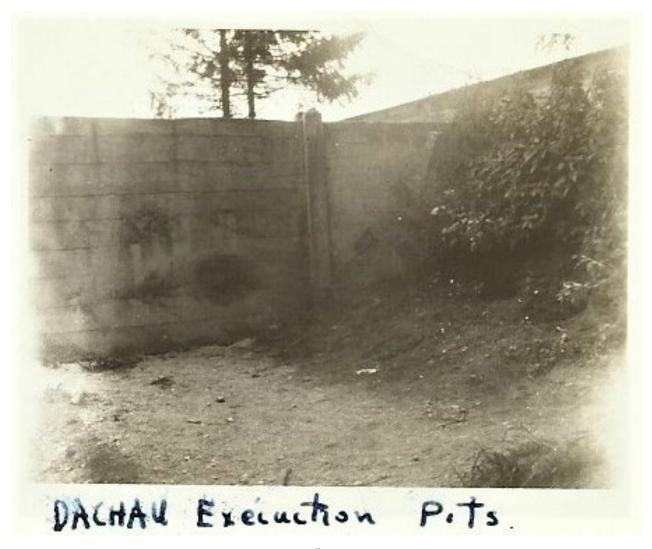

For reasons unknown, the SS never used Dachau's operational gas chamber for mass extermination. Gunshot and hanging were the most frequent form of execution at Dachau.

Typically, inmates selected to be gassed were sent to the Hartheim Euthanasia Centre, 149 miles to the east. Likely several thousand Dachau inmates were gassed there.

Dachau's gas chamber became operational in 1944 and was used in an unknown number of deaths. Also unknown is how many of those were executions, and how many were part of ongoing SS medical experiments performed at the camp.

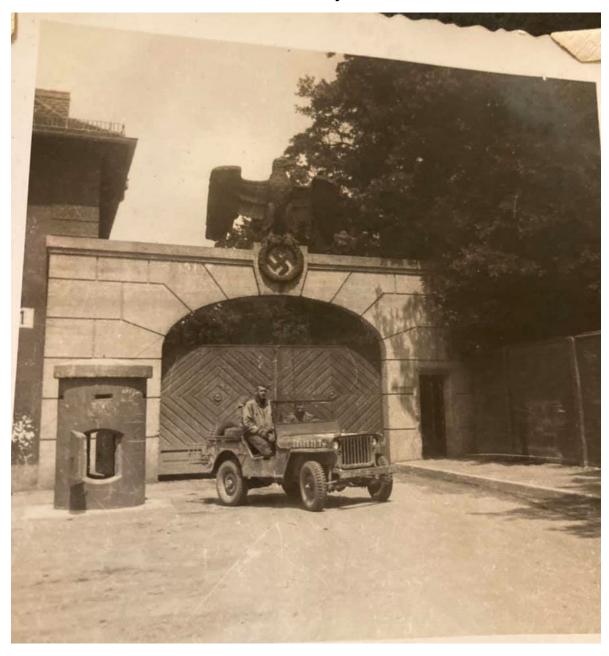

On April 28, 1945, with American troops just across the Amper River, anti-Nazis in the town of Dachau staged on uprising. Among the resisters were escapees from the concentration camp. The SS quickly suppressed the uprising and killed as many of the resisters as they could capture. Their bodies were public displayed. This is tentatively identified as a photo of bodies of the resisters on display in the town of Dachau.

The resisters do not appear to have coordinated the uprising with the nearby American troops. Except for the August 1944 Paris uprising when the 2nd French Armored Division quickly came to the support of the resistance, all similar uprising were crushed by the Nazis before Allied or Soviet troops linked up with the resisters.

Included are (21) Dachau photos illustrating what soldiers of the 20th Armored Division saw and experienced during liberation.

Seven appear in the collection of the late S/SGT Wilburn Smith (Co. A, 27th Tank Bn.), and are also included here.

One is similar to a photo in the collection of the late T/4 Hubert Paul (HQ Co, 27th Tank Bn.).

At least two are by U.S. Army Signal Corps photographers.

One is a post-liberation photo, and probably not a 20th AD soldier's.

The photographers of the remaining six are not identified.

20th Armored Division led the way to its capture by Infantry troops.

20th Armored Division troops were there and saw its nauseating horror.

Here was the proof of cruelty, sadism, ruthlessness, of every vicious characteristic of which man can be guilty.

Hardened veterans of war looked and retched. It was that bad. The pictures on these pages will

bring it back to those who saw. Only that penetrating, clinging, faint, undefinable, horrible odor of death will be missing. They will be memories that perhaps men would rather forget, but they are necessary if only as a permanent warning against what can happen with people gone mad on warped ideologies. When superrace, racial prejudice, political persecution doctrines deprive men of their humanity.

Here was the black core of Nazism. Here was the awful indictment of a people who followed an idea, "Might is right."

On a siding entering the campus-like exterior of the death camp and still in view to the neat, quaint little village of Dachau was one of the many death trains that had come to that notorious concentration lager.

Some 40 box cars were still full of their grisly cargo, starved men, humans that no longer looked like humans, just skin-covered

skeletons, clad in striped pajama suits. They were dead, lying grotesquely, one on the other, in the residue of animal living. A few, still alive when the train reached Dachau, lay on the tracks beside the cars where they had stumbled out, only to die.

They had been alive when the train started from somewhere. It was intended they be dead on arrival, to be disposed of in the five crematoriums of the camp.



were corpses

. . few corpses lived—but most will die

The rest of the camp was a continuation of horror. . . . dead, bone-thin bodies stacked like cordwood outside the gas chambers where they had met death. . . . yards long pile of clothes, mute evidence of other hundreds of nameless men who had died to feed the Nazi machine. . . exuberant prisoners, the living dead, stunned at freedom . . . doomed to die despite liberation . . prisoners drunk with looted wine, . . prisoners squatting native fashion over small fires cooking looted stores. . . . dead SS guards, heads bashed in . . . kennels with a bullet riddled dog in front, a dog that once had been used to kill when other methods became dull. . . oxtail whips, steel black jacks, instruments of persuasion. . . .



and the stories from prisoners only too glad to talk to American soldiers. . . . stories of hanging for hours from the wrists which had been tied behind the back, of death in winter by men being stripped and held under a hydrant hose, frozen stiff in the morning, of barbarity beyond description, beyond imagination in a 20th century western civilization.

And only a half a mile away was a church, and another half a mile was a roadside crucifix.

That was Dachau, synonymous with death, despair.
